LIABILITY

J5 Rolloffs is not responsible for any damage to Customer's property during dumpster placement or removal. J5 ROLLOFFS SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL, EXEMPLARY, INCIDENTAL, INDIRECT, MATERIAL, PUNITIVE, SPECIAL, SPECULATIVE DAMAGES, OR ATTORNEYS' FEES OR COURT COSTS ARISING IN ANY MANNER PURSUANT TO OR IN CONNECTION WITH THIS CONTRACT, AND/OR THE SERVICES PROVIDED HEREIN.

PAYMENT

Payment is due immediately upon delivery of the dumpster to Customer's Address as set forth herein.. Cash or Venmo

CANCELLATION

Customer may cancel this Contract only upon no less than 24 hours' prior written notice to J5 Rolloffs. J5 Rolloffs reserves the right to

cancel or reschedule due to unforeseen circumstances.

DISPOSAL

Rental Company J5 Rolloffs is responsible for disposing of the contents of the dumpster in accordance with local, state, and federal regulations.

INDEMNIFICATION

The Customer shall defend and hold harmless J5 Rolloffs, and its owners, officers, directors, employees and agents from and against all losses, damages, costs, expenses (including without limitation legal fees and expenses), liabilities, claims, suits, actions and causes of actions (collectively the "Losses") whatsoever, sustained or incurred by J5 Rolloffs, its owners, officers, directors, employees and agents, arising directly or indirectly as a result of the negligent acts and/or omissions of the Customer and/or its successors, assigns, directors, officers, agents, subcontractors, consultants, employees or others.
