Following the Pledge of Allegiance, the Apollo Borough council meeting was called to order by the Council President Jerrod Thompson at 7:00 p.m. at 631 N 2nd Street, Apollo PA 15613 (Soldiers & Sailors Hall).

Present: Council members Jerrod Thompson, Mark Tarle, Cindy O'Block and Kenneth Cyphert were present. The Mayor, Secretary/Treasurer, Solicitor and Engineer were present. Council members Craig Williams, Cindee Virostek and Diane Bradshaw were absent.

Public Comments:

Dan Busatto from Century Insurance discussed liability insurance renewal and was present for council if they had questions.

Ken Skinner questioned the plans he has been hearing about an apartment building being built in place of the old school in town. He heard they plan to demolish the building and has questions about the asbestos removal if this is going to happen. He said he will ask for reports from the company doing the removal because he also does asbestos removal and wants to make sure it is done properly and safely.
