Motion made: to authorize Sherry Sabatino to participate/vote via phone for the Organizational meeting by Cindy O'Block, seconded by Mark Tarle, motion passed unanimously.

Jeanne Rummel, Cindy O'Block, Jerrad Henry, Ken Cyphert and Michelle Beck voted for Jerrad Henry. Jerrad Henry was elected Council Vice President by majority vote.

Nominations for President Pro Tem opened. Cindy O'Block nominated Cindy O'Block, seconded by Michelle Beck. Ken Cyphert nominated Mark Tarle, with no second. Shery Sabatino nominated Sherry Sabatino, seconded by Mark Tarle. Cindy O'Block was nominated as President Pro-Tem by majority vote.

Motion made: by Cindy O'Block, seconded by Jeanne Rummel to appoint Kristina Fox as Chair of Apollo Borough Vacancy Board. Motion passed unanimously.


