



SERVICE AGREEMENT BETWEEN OHIO PUBLIC EMPLOYEES DEFERRED COMPENSATION BOARD AND RVK, INC.

AMENDMENT 2

This Second Amendment (Amendment 2) to the Service Agreement (Agreement) between the Ohio Public Employees Deferred Compensation Board (Ohio DC) and RVK, Inc. (Consultant) dated the 24th day of February, 2017 is made by and between Ohio DC and Consultant.

The purpose of this Amendment 2 is to extend the Agreement and amend Section II, Term and Section V, Compensation-Fee Schedule.

Ohio DC and Consultant would like to amend Section II of the Agreement to extend the Agreement term for an additional five-year period beginning on April 1, 2022 and ending on March 31, 2027.

II. Term

The contract shall have a term of five years with a beginning date of April 1, 2022, and ending date of March 31, 2027, subject to the following terms and conditions. Revisions to the contract during the contract period or any extensions shall be by mutual agreement. State appropriated funds will not be used for payment of these services; however, both parties understand that if appropriated funds are used by Ohio DC for payment of these services, then this Agreement itself will be limited to the State of Ohio biennium currently therein.

Ohio DC and Consultant would like to amend Section V to reflect the compensation to be paid during the five-year period.

V. Compensation-Fee Schedule

The annual fee schedule beginning April 1, 2022 will be:

Year 1	\$177,000
Year 2	\$182,000
Year 3	\$187,000
Year 4	\$192,000
Year 5	\$197,000



To the extent it is necessary to conduct investment manager searches: Consultant will assist in the completion of such services for no additional fee for a maximum of three searches in any calendar year. Any additional searches beyond this will have an additional cost that ranges from \$5,000 to \$20,000 per search depending on the asset class. Additional Consultant services may be provided on request by Ohio DC as offered in the Cost Proposal.

The base annual fees will be prorated and billed quarterly at the beginning of each calendar quarter. Any additional services requested by Ohio DC to be performed will be charged on an hourly -rate or fixed-fee basis.

All provisions of the Agreement remain in full force and effect, except as specifically amended herein.
