# 2024 GRAND COMMUNICATION RECAP OF PROPOSED CHANGES

## Resolution Vote Outcome- 2023

### **Grand Master's Recommendation 2023-01 Passed**

Lodge Seal Facsimile Stamp (Required 5/6 majority for adoption)

Synopsis: This recommendation proposes to permit the use of a Lodge seal facsimile stamp on any Lodge document except dues cards. Use on dues cards is prohibited since the ink would obscure much of the information on the card.

### **Resolution 2023-01 Carry Over**

Annual Communication Emergency Provisions

Synopsis: This Resolution proposes to add emergency provisions to Constitution Article II, following §2-2 Annual and Special Communications. Adoption will give the Grand Lodge of Arizona procedures to be followed in the event of an emergency situation and will allow a modified Annual Communication to be held.

### **Resolution 2023-02 Passed**

Amendment of Constitution Trial Sections 9-2, 9-3, 9-4

Synopsis: Constitution §9-2 contains errors and inconsistencies in this sentence "The Grand Master may determine whether the charges are frivolous and whether they constitute a Masonic Offense, after which he will proceed, or return the charges to the Brother or Brothers who originally filed them."

### **Resolution 2023-03 Passed**

Amendment of Statute Section 17-501

This Resolution is to be considered only if Resolution 2023-XX2 has been adopted.

Synopsis: It is not practical for the Grand Lodge to be involved with a trial at the Annual Communication only being in session for 2 days and being convened for other purposes.

### **Resolution 2023-04 Passed**

Wardens and Others Who May Open a Lodge

Synopsis: This Resolution proposes to update and clarify the requirements to open a Lodge when the Master and Wardens are not present. The original source of the last sentence of this current Section is an approved decision of the 1923 Grand Lodge. Who the phrase "legally authorized representative" referred to in 1923 is uncertain, but that is now the DDGM and should be so stated. Documentation required for this action is also included in this proposal.

### **Resolution 2023-05 Failed**

Background Checking Service

Synopsis: Recent developments have confirmed that our Lodges must do a more complete investigation of men who apply for membership. Some Lodges currently employ a background checking service to assist them. All Lodges in this jurisdiction should be using such a service. Subject to the provisions of the AMC, all applicants should be treated in the same manner. Adoption of this Resolution will require an addendum to be attached to each petition and affiliation form with information described in the following proposal. Guarding the West Gate is a private company operated by retired NYPD detectives who are Freemasons. The report fee is currently sixteen dollars (\$16.00)

**Resolution 2023-06 Passed**

Statute Section 13-301

Synopsis: This Resolution proposes to correct and amend Statute Section 13-301. The vote to remove an officer can't always be held at the next stated meeting which would in most months be held 28 days after presentation of the resolution.

**Resolution 2023-07 Passed**

Reporting Trial Commissioners

Synopsis: There is a need for the information on elected Trial Commissioners, who are never installed, to be transmitted to the Grand Secretary before the installation of officers which could be as long as 60 days later. This Resolution proposes that information on Trial Commissioners be transmitted and uploaded immediately after election and that officer information be transmitted immediately after election as now required, and also uploaded by the Secretary.

**Resolution 2023-08 Carryover**

Ritual Correction of Stewards Seating

Synopsis: There has been an ongoing discussion in Central Arizona Lodge #14 as to the proper seating positions of the Senior and Junior Stewards. Refer to receiving the jewels when opening a Lodge, Ritual pages 4, 53 and 99. These instructions indicate that the Jr. Steward sits nearer to the Master, to the right of the Jr. Warden, with the Sr. Steward on the Jr. Warden's left. This would seem to be backwards as the Jr. Steward is to be at the North end of the line, then the Sr. Steward, and then the Marshal before retiring. (Ritual page 10)

**Resolution 2023-09 Carryover**

Constitution §3-1.4.3

Synopsis: This Resolution proposes to amend Constitution §3-1.4.3 to note the authority to employ outside office help, to define the qualifications of the Deputy Grand Treasurer and to grant him the privilege to vote, and more importantly, to speak as a member of Grand Lodge. This Resolution should be considered in conjunction with Resolution 2023-10.

**Resolution 2023-10 Passed**

Statute Section 14-101

Synopsis: This Resolution proposes to recognize the specialized knowledge necessary to perform the duties of Grand Treasurer and Deputy Grand Treasurer

**Resolution 2023-11 Passed**

Statute Chapter 18

(Requires 2/3 majority for adoption)

Synopsis: As Trial Commissioners no longer come from a single Lodge, it is necessary to amend the wording of many Statute Sections

**Resolution 2023-12 Passed**

Constitution §6-1

Synopsis: This Resolution proposes to separate and also supplement the information concerning Lodges and Research Lodges. The current title of Constitution §6-1 is misleading and confusing.

**Resolution 2023-13 Passed**

Statute Section 10-705 – Alcohol Policy  
(Requires 2/3 majority for adoption)

Synopsis: The purpose of this Resolution is to further emphasize the responsibility for careful management when alcoholic beverages are present at any Lodge activity and that Lodge funds are not to be expended for them.

**Resolution 2023-14 Passed**

Minor Statute Corrections  
(requires 2/3 majority for adoption)

Synopsis: The following minor corrections are proposed for the following Statutes. Only the paragraphs proposed for amendment are printed.

**Resolution 2023-15 Passed**

Statute Cross-references (2/3 majority required for adoption)

Synopsis: The following Cross-references are proposed for these Statute sections and sub-sections. Only the paragraphs proposed for amendment are printed. Some single word corrections are also proposed.

**Resolution 2023-16 Passed**

Constitution Cross-references  
(5/6 majority required for adoption)

Synopsis: The following cross-references are proposed for the following Constitution Sections. Other minor amendments are also proposed.

**Resolution 2023-17 Passed**

Refusal of Charges Appealed  
(Requires 2/3 majority for adoption)

Synopsis: The decision by a Lodge Master to accept or reject charges of un-Masonic conduct is a judgement call delegated to him by Statute Section 18-202.

**Resolution 2023-18 Withdrawn**

Right to Visit  
(Requires 2/3 majority for adoption)

Synopsis: Violations of Statute Section 9-102.1 are occurring in our Jurisdiction. This resolution proposes to amend this Section to emphasize that this must cease as it is a violation, placing the charter of the lodge in jeopardy. When installed every Master is specifically charged and agrees to this regulation.

### Resolution 2022-04 Passed

Ritual Change

Pursuant to resolution 2021-03, the term regular has no meaning in the AMC...

### Resolution 2022-11 Failed

Calling to Refreshment

The purpose is to amend the Ritual supplement adding a section for "Calling to Refreshment..."

### Resolution 2022-03 Failed

The purpose is to correct the misuse of the honorific title "Worshipful Master."

### Resolution 2022-10 Passed

To correct an error on page 133 of the Ritual.

### Resolution 2022-12 Failed

During the installation of the master, he gives assent to a number of "ancient charges..."

### Resolution 2022-13 Failed

The second sentence of the E.A. lecture states a "recapitulation of the ceremonies" will be omitted.


