Medicare Extra Help Program / Low-Income Subsidy

The *Medicare Extra Help Program*, also referred to as *Low-Income Subsidy* (LIS), is a federal program (administered by the Social Security Administration) for Medicare beneficiaries with limited income and resources enrolled in a MAPD or PDP plan.

Medicare beneficiaries who qualify for the Medicare Extra Help Program will either receive Full or Partial subsidy assistance. The amount of the subsidy will vary based on certain income and asset guidelines, and will apply to the following Medicare Part D costs:

- Part D Premium
- Part D Deductible
- Part D Copays
- Part D Late Enrollment Penalty (LEP)

How Does It Work?

How to Qualify and Enroll a Client:

- 1. Members will automatically qualify for Extra Help if they have Medicare and meet any of the following conditions:
- Receive full Medicaid coverage, or
- Receive help from Medicaid paying their Medicare Part B premium, or
- Receive Supplemental Security Income (SSI)

Members who automatically qualify for the Extra Help Program will receive a letter (a "deemed status notice" or "auto enrollment notice") from CMS confirming the member has qualified for the program and will be enrolled.

- 2. Members who don't automatically qualify may still apply for Extra Help, when they meet certain income and resource requirements, by:
- 1. Calling:

- Their local State Medicaid Office

Special Election Period

When a member qualifies for Extra Help, he/she also becomes eligible for a Special Election Period (SEP), during which:

- They can switch Medicare prescription drug plans (PDP or MAPD) quarterly during the first nine months of the year, in addition to their standard Annual Election Period (AEP) process.
- Coverage starts the first day of the month after they enroll in a plan

Frequently Asked Questions

Where can I find the LIS Lookup Tool?

• Enroll a prospect on Ascend App. After the initial required info of Plan and Zip. Top of the screen is a link to Extra help eligibility. First name, last name, DOB, and Medicare number is required. The tool will tell you the category and % level of LIS.

 Yes, Extra Help payments count toward a member's Part D out-ofpocket costs.

What should members do with letters that they receive from Medicare regarding their eligibility and/or qualification?

 Members are encouraged to keep the letter(s) received from Medicare for their records since copayment levels and benefits may change annually.

Does the application for Extra Help also enroll a member into Medicaid?

 No, the application is for Extra Help with Medicare prescription drug costs and does not enroll Medicare beneficiaries into Medicaid. If a member would like to apply for Medicaid, they should contact their state Medicaid office
