HerdFund Investor Terms & Conditions

1. Introduction

- 1.1 These Terms & Conditions ("Terms") govern the relationship between **HerdFund (Pty) Ltd** ("HerdFund", "we", "us", "our") and each person or entity who invests in cattle through the HerdFund platform ("Investor", "you").
- 1.2 By purchasing cattle or cattle shares through HerdFund, you agree to be bound by these Terms.

2. Nature of Investment

- 2.1 Investments made through HerdFund are linked to cattle owned, managed, and maintained by HerdFund on behalf of Investors.
- 2.2 Investors acquire **ownership or beneficial interest** in cattle or cattle shares, subject to HerdFund's management obligations.
- 2.3 The investment is **not a guaranteed return product**. Returns depend on livestock performance, market conditions, and other agricultural risks.

3. Management of Cattle

- 3.1 All cattle will be housed, grazed, and managed on farms leased or operated by HerdFund.
- 3.2 Investors agree that HerdFund has full discretion on:
- Breeding and re-breeding cycles
- · Veterinary care
- Sale of cattle and offspring
- · General herd management
- 3.3 Investors may not directly interfere with day-to-day management.

4. Fees & Commission

- 4.1 HerdFund reserves the right to charge earns a **10% commission** on each cattle sale and a **10% commission** on the sale of cattle offspring.
- 4.3 Fees and commissions may be amended on written notice to Investors.

5. Investor Returns

- 5.1 Profits are derived from the sale of cattle and offspring.
- 5.2 Net proceeds (after costs and commission) will be distributed to Investors in proportion to their ownership interest.

5.3 Payouts are made only after sale and settlement of accounts.

6. Risks & Disclaimers

- 6.1 Investing in livestock carries risks, including but not limited to:
- · Disease outbreaks
- · Mortality of cattle
- · Market price fluctuations
- · Drought and environmental conditions
- 6.2 Herd Fund will take reasonable steps to manage risks but does not guarantee returns.
- 6.3 Investors accept that past performance is not indicative of future results.

7. Investor Obligations

- 7.1 Investors must provide accurate information for compliance with FICA and other applicable laws when requested.
- 7.2 Investors must promptly pay any fees or contributions due.
- 7.3 Herd Fund may suspend or terminate an investment if an Investor breaches these Terms.

8. Withdrawal & Termination

- 8.1 Investments in cattle are generally illiquid until sale.
- 8.2 Investors may request an early withdrawal, but HerdFund is under no obligation to repurchase shares in cattle.
- 8.3 HerdFund reserves the right to liquidate cattle in the event of insolvency, force majeure, or regulatory order.

9. Legal Compliance

- 9.1 HerdFund operates in accordance with South African company law, tax law, and agricultural regulations.
- 9.2 Investors are responsible for their own tax obligations arising from profits or distributions.

10. Limitation of Liability

- 10.1 HerdFund, its directors, and employees shall not be liable for any loss or damages (direct or indirect) unless caused by gross negligence or willful misconduct.
- 10.2 Investors acknowledge that they are investing at their own risk.

11. Governing Law

These Terms are governed by the laws of the Republic of South Africa.

12. Amendments

- 12.1 HerdFund may amend these Terms on written notice to Investors.
- 12.2 Continued participation by Investors will constitute acceptance of the amended Terms.
