

Our Process

2021

Welcome to the year you learn who you are and how you came to exist through the many ancestors that came before you.

Our Process is Simple

Step 1

First, after you purchase you will receive an email based on your purchase that aligns with the service description you purchased.

We ask for the following, including the birth date/location for each ancestor remembering the maiden name of those that have been married.

- a. Your Legal Name
- b. Your Maternal Grandfathers Name
- c. Your Paternal Grandfathers Name
- d. Your Maternal Grandmother (maiden name)
- e. Paternal Grandmother (maiden name)
- f. Both Parents Names
- g. If half project, which side you would like us to search (mother or father)?
- h. Your Instagram Profile Name
- I. Were you referred by anyone, if so who?

It is so very important that we get these facts as close to possible because this is what we will use to start our initial search.

If there are errors in the information provided it would cause errors later.

If your grandparents were born prior to 1940 we may request an additional generation.

Step 2

Next, we provide an initial search. We usually try to get this right and will send an Ancestry Link for review and compare our facts with the history you may know about your family.

This initial search can take up to 2-3 weeks (please also note delays in COVID-19)

Once this is received, please know that this is not the final search. This is a way for us to research as much as possible, go back as far as we possibly can using the records and understand which lines may pose an issue for continued research that require focus to understand why and attempt to unravel the lives of ancestors.

Please Note:

If you are on a payment plan this search will be completed in part. We will be limited in what we provide until payment is made in full.

Step 3

After we have completed the initial search and client has reviewed, we then move forward deeper in your family tree, searching documents, archives, name variation, reverse searches using siblings and other key documents that could possibly unravel your family history.

During this search it may appear as though it has become stagnant this is typically because we are periodically reading through different family narratives, possible connections, migrations, and name changes that might have occurred to stall this.

Step 4

Once the deep search has been completed, we then prepare the final project for review. For each line that we were able to go further back we provide you with the documentation as well as the reasoning used to deduce their identity.

If we are unsuccessful for finding the lineages further back since the initial search, we provide you with our research methodology, challenges and record unavailability to which caused such limits on our research and our attempts supported by documentation.

Once we have completed you will receive a final link to Ancestry, with all documentation used and needed to complete.

Step 5

(Optional Aboriginal Search)

After we have completed the initial search, we will begin reviewing Native Rolls, aligning with Native American History and name variations, historic documents and other sovereign material that may support indigenous identity.

Please Note: We offer research for the aboriginal search however we do not provide any legal advice as to next steps. We do provide you with any and all documents and research that support our research to validate any indigenous ancestor.

If you purchase an aboriginal package this covers one line. If you would like both lines researched, you would need to purchase 2 aboriginal packages for a full project or one for only half of your family.
