Rereading the Declaration Of Independence

When was the last time you read the Declaration of Independence? Grade school? High School? Everyone should take the time to read it again, especially in today's world. It was an environment of no running water, no drugstores or grocery stores, mud everywhere. You traveled by foot, horse or wagon. It could take John Adams weeks to commute from Massachusetts to Philadelphia. In the meantime, his wife had to tend to the family and the farm. Life was a bitch.

Our founding fathers and their families put a lot of their life into starting this country. Their actions were subject to hanging by the King. Most of the members in our current body in Congress and the White House would not have survived. Not just the physical challenges, but the mental acuity and honesty to represent our country. They are weak when it comes to standing for what is truthful and just in governing the country. For centuries Christianity was the basis for society's rules in Europe. This trend led Neitzche to proffer that as science affected some of the values and beliefs held by the people they would move away from their moral principles and look for another type of "religion." He feared that religion would be the secular promises of fascism and communism. (Sound familiar? Pro-abortion, redefine the language, subordinate control of the press and the media.)

The second paragraph of the Declaration of Independence lists our "unalienable" rights of Life, Liberty and the Pursuit of Happiness among others. It goes on to state that whenever any Form of Government becomes destructive of these ends then it is the Right of the People to alter or abolish the government. Keep this in mind as we watch our freedoms and liberties being taken away in the name of the public good. We are the public. Taking away our freedoms is never for our good. It only benefits the rulers.
