**AGREEMENT**

Noah's Bark Pet Rescue provides food, supplies and veterinary care. You provide love, transportation to and from adoptions, a stable environment, shelter and affection.

This Agreement is entered into between Noah's Bark Pet Rescue and the undersigned, hereinafter referred to as the Foster:

1. Foster agrees to give the fostered dog food, indoor shelter, any prescribed medications and kind and loving care for a limited period of time. Foster agrees to notify Noah’s Bark Pet Rescue immediately if the dog escapes or becomes ill. \_\_\_\_\_ (initial)
2. Foster understands that Noah’s Bark Pet Rescue may not have prior knowledge of the dog’s temperament, and will take due care to protect any person or pet who may come into contact with the dog from harm. \_\_\_\_\_ (initial)
3. Foster will not seek to hold Noah’s Bark Pet Rescue responsible for damage to property or injury to persons or other animals. \_\_\_\_\_ (initial)
4. Foster agrees to inform Noah’s Bark immediately if there are any health concerns with the fostered dog. Foster also agrees to request and receive permission from Noah’s Bark before taking the fostered dog to a vet, medical care facility, groomer, or dog park. \_\_\_\_\_ (initial)
5. Noah’s Bark Pet Rescue will be financially responsible for any veterinary care it deems necessary for the fostered dog at a veterinarian of Noah’s Bark Pet Rescue’s choice, if prior approval has been received by Foster from Noah’s Bark Pet Rescue. Noah’s Bark Pet Rescue will not cover or reimburse any costs associated with veterinary or wellness care received by fostered dog without prior approval and/or at a veterinary hospital or facility not selected by Noah’s Bark. \_\_\_\_\_ (initial)
6. Foster agrees that any dog fostered by him/her is the property of Noah’s Bark Pet Rescue and that Foster will not relocate the dog from the primary residence of Foster or dispose of it in any manner without prior notice to and approval by Noah’s Bark Pet Rescue. \_\_\_\_\_ (initial)
7. Noah’s Bark Pet Rescue has the right to revoke the fostered dog at any time. Foster will return the dog to a Noah’s Bark Pet Rescue representative immediately upon request. \_\_\_\_\_ (initial)
8. If Foster desires to adopt the dog, and Noah’s Bark Pet Rescue agrees the adoption is appropriate, Noah’s Bark Pet Rescue will provide an Adoption Agreement to the Foster. Foster agrees to sign and return said agreement within 7 days of receiving it, together with said dog’s adoption fee, unless other arrangements have been agreed to in writing. \_\_\_\_\_ (initial)
9. Foster agrees to bring foster dog to and from the weekly Saturday adoption fairs, unless other arrangements have been pre-agreed upon. Please arrive by 12pm to drop off your foster dog and arrive by 3pm for pick up. \_\_\_\_\_ (initial)
