The meeting was called to order at 6:30pm.

## **Re-organization Meeting**

- Multiple board members raised concerns regarding conducting the re-organization meeting while we do not have someone interested in the treasurer's position with the necessary background. Discussed posting the open board positions on all forums – Mars Planet Foundation website, MASD website, Facebook, Twitter, e-Communicator.
  - Action Items: Tricia Holland will assemble the advertisement. Carol Knox will send the information to the school district to post via the e-communicator and the website; Wyatt Lee will post on the Facebook page, MPF website, and send a message through Mobilecause to our contact list.
- Discussed the Treasurer's position at length and agreed that we are looking for someone with a financial background to take the position; stressed the importance of this position being filled.
- Discussed the need to create a nomination committee for future elections.
- Discussed the need to re-do the current committee roles available in the organization.

## **Teacher Grant Report – Carol Knox**

- Carol Knox gave an update regarding Mrs. Allhouse's teacher grant for the greenhouse. Mrs. Allhouse was moved from the middle school to the high school and the teacher taking over her position at the middle school was not interested in taking over the project so Mrs. Allhouse has moved the greenhouse project to the High School. Therefore, the greenhouse will go live in February. She will send pictures and information as soon as she has some available.
- Carol Knox provided an update regarding Mrs. Hindrichsen's teacher grant for a large map of Mars and the Moon. The project received public attention with a write up in the Cranberry Eagle.
- Carol Knox will contact the principals to encourage grant submission and discuss the possibility of an MPF board member attending occasional faculty meetings.
- Discussed the potential of having teacher liasons for each building as well.

  - Kean Foundation STEM Scholarship (\$2,000)
    - Amount and criteria will remain the same.
  - Kean Foundation Arts Scholarship (\$2,000)
    - Amount and criteria will remain the same.
  - New Scholarship? MPF School Spirit Scholarship.
    - The Foundation will postpone the implementation of this new scholarship until the 2022-2023 school year.
    - <u>ACTION ITEM</u>: Vickie Zaccari will work to create criteria so the scholarship is ready by November 2022.
- Awards banquet will not be held offsite instead the school will host an academic ceremony on-site.
  Date is TBD. The Board briefly discussed paying for signs for all seniors since we will not incur expenses for the banquet.
