<u>Fees</u>

Application Fee: The application will be processed upon receipt of a non-refundable application fee (see attached rules for applicable fee). Both the application and fee payment can be submitted in person at or mailed to 409 US Hwy 377 S, Argyle, TX 76226. Please make checks payable to Argyle Party and Gift. Credit cards are accepted. Returning vendor status or the date of the application will determine priority in selecting space assignment. The market will notify approved vendors via an acceptance email. Current pricing will remain in place for the year in which application is made. If application is received by

December 31, 2024, prior year vendors will also receive priority placement for the next years space assignment. All applications are requested no later than March 1 (except for 2024 in which case the application deadline is April 30, 2024).

#### Requirements

### **Licenses, Permits, Certifications & Inspections**

Vendors are required to comply with all Federal, State, and local laws governing food safety and labeling. Please email relevant copies with application of current licenses, permits, certifications, and inspections to argyletxfarmersmarket@gmail.com.

## **General Liability Insurance (required for all vendors)**

\$1,000,000 minimum – Please email a copy to <a href="mailto:argyletxfarmersmarket@gmail.com">argyletxfarmersmarket@gmail.com</a> and be sure that the Argyle Farmers Market is listed as the "Certificate Holder" and "Additional Insured" that shows current coverage for 2024. Upon acceptance as a vendor, a vendor must provide proof of insurance within 30 days. Hold Harmless Provision – A Hold Harmless clause is included below as part of the agreement with vendors. Each vendor participating in the Argyle Farmers Market shall be responsible for any loss, personal injury, deaths and /or other damage that may result from vendor's negligence or that of its agents, representatives, and employees, and hereby agrees to exonerate, save harmless, protect and indemnify Argyle Farmers Market, its successors and assigns, from and against any and all losses, damages, claims, suits or actions, judgments and costs, and attorneys' fees which may arise or grow out of any injury or death of persons or damage to property in any manner connected with the vendor's products, operations or vending at the said market. In addition, each vendor agrees to release and hold harmless Argyle Party and Gift LLC, host of the farmers market parking lot site, from all claims relating to property damage, or personal injury to self, family members and employees related to participation on the market site or its related parking areas.
