# Canyon Ridge Guiding, LLC

### **Hunt Contract**

This agreement entered between Canyon Ridge Guiding, LLC and the sportsman sets out all aspects of the complete agreement between parties and reflect the final agreement concerning the services to be performed and goods provided by Canyon Ridge Guiding LLC, as well as respective rights and duties of the parties. The final resolution of all previous discussion and negotiations are set forth below, and there are no implied terms to this agreement other than those expressly set forth herein. You are purchasing a "fair chase" hunt. As such, this contract, or any articles herein, do not guarantee or promise the below undersigned an opportunity to harvest the species being hunted or pursued.

- 1. The following service and equipment provided by Canyon Ridge Guiding LLC:
  - Transportation during the hunt, upon request. (From lodging, to hunt area, and return to lodging.)
  - Game handling in the field, to the lodge or meat processor, and/or local taxidermist if so desired.

# 2. Sportsman shall provide:

- All personal effects such as: towels, toiletries, hunting equipment, binoculars, rain gear, etc...
- Weapon and ammunition, which are legal for taking game in the state of Arizona. (Check Arizona Game and Fish Department regulations.)
- Participants are required to carry on their person a compass, water, hunt license, tag, driver's license and appropriate rain gear and clothing sufficient for changing conditions.

# 3. Sportsman's Duties and Responsibilities:

- Conduct themselves in a polite manner.
- Practice firearm safety.
- No consumption of alcohol during hunting hours.
- Observe all Canyon Ridge Hunting and safety procedures as detailed in a pre-hunt orientation and as may be directed by Canyon Ridge Guiding, LLC guide(s).
- Strictly adhere to all Arizona Game and Fish and US National Forest Rules and Regulations.
- Sign and deliver Acknowledgement of Risk along with this hunt contract.

#### 4. Payment

- Deposits represent a reservation of space that will then be unavailable to other hunters. A non-refundable deposit of 50% of the cost of the booked hunt is due at the time of booking along with this signed contract.
- Final Payment must be made in form of cash, money order or any form of major traveler check(s) upon arrival. Personal checks will not be accepted for final payment.

- There shall be no refund or prorating due to inclement weather, nor for any other reasons beyond the control of Canyon Ridge Guiding, LLC.
- If the sportsman is unwilling to abide by all the terms of this agreement, Canyon Ridge
  Guiding, LLC reserves the right in its sole discretion to cancel the hunt and refuse further
  service to the participant without refund.
- For any animal hunted on a trophy fee basis, the hunter shall pay the trophy fee when an animal is killed or wounded.

# 5. Confidentiality

 The hunter(s) hereby agree to not publically document or post in print, online, video, or audio anything about their hunting trip, or anything about Canyon Ridge Guiding, LLC including, but not limited to: Hunting locations, game densities, satisfaction, dissatisfaction or impressions about the hunt without expressed written consent of Canyon Ridge Guiding, LLC.

Canyon Ridge Guiding, LLC relies on your representations herein that you have sufficient hunting skills, the physical and mental capabilities for the type of hunt booked and an intimate knowledge of the operation of your weapon. All physical limitations or health problems must be made known to Canyon Ridge, LLC, in writing, with this hunt contract, as well as verbally, to your guide prior to your hunt. Participant assumes all responsibilities for any known or unknown physical or mental condition. In the event sportsman's abilities defined herein changes between the hunt contract date and the hunt date, Sportsman hereby acknowledges and understands that it is their duty and responsibility to notify Canyon Ridge Guiding, LLC of change as soon as sportsman becomes aware of a change in their capacity to complete the hunt.

Hunting procedures depend on weather, game conditions, and the skill and physical conditions of the hunter(s). Canyon Ridge Guiding, LLC, in its sole discretion, can change hunt areas and methods to best increase your opportunity for a successful hunt.

Each undersigned acknowledge that he/she has read all the information provided by Canyon Ridge Guiding, LLC and agrees that the content and said material coincides with all the information received by verbally by Canyon Ridge Guiding LLC. Where differences exist, this contract controls. This agreement shall be binding upon the parties hereto, their heirs, representatives, or agents and shall not be assigned without the specific written approval of all parties.

By signing below the parties acknowledge that they understand all the terms of this contract and furthermore agrees that this contract shall be governed by the laws of the State of Arizona, both as to its interpretation and performance.
