Your name will only be placed on the ballot if you submit a fully completed Candidate Information Form so that it is physically received by the Association on or before October 5, 2025.

A candidate who is interested in running for a position on the Board must be available to (i) attend Board meetings, (ii) assist with Association projects on a weekly basis, (iii) assist with owner or resident issues, (iv) read and answer emails, (v) attend training sessions, and (vi) serve in an appointed capacity, such as, by way of example, as an officer on the Board or as a liaison to an Association committee.

Please note that the Texas Property Code (the "*Code*") disqualifies a person from serving on the board of directors for a property owners association if the person has been convicted of a felony or crime involving moral turpitude in the past 20 years. In addition, the Code prohibits 2 persons who live at the same residence from serving on the Board of Directors at the same time.

Additionally, please note that, if you choose to respond to the questions on the Candidate Information Form, your responses (excluding your address, phone number, and email) may be distributed to the Members of the Association along with the 2025 Annual Meeting materials. You will receive more information about the 2025 Annual Meeting in the upcoming weeks.
