1. OPENING OF THE MEETING

Anne Harper, chairperson, opened the meeting and welcomed all present. It was noted that there were 19 voting members in attendance.

2. APOLOGIES

Apologies received were noted.

3. MINUTES OF THE PREVIOUS ANNUAL GENERAL MEETING

The minutes of the Annual General meeting held on 21 June 2024 were received and accepted. Proposed by Sophie Pike and seconded by Jill Masdin. All in favour.

4. MINUTES OF THE EXTRAORDINARY GENERAL MEETING

The minutes of the Extraordinary General meeting held on 24 July 2024 were received and accepted. Proposed by Fliss von Christian and seconded by Catt Putt. All in favour

5. MATTERS ARISING

5.1 Insurance

The NCNA were aware of the insurance covers provided by being a member of England Netball – namely Liability Insurance (Employers, Public & Products Liability) and Personal Accident cover.

However, it was felt that clarification was required regarding Tournaments that were being organised and where some participants were not EN members. This was put to EN who advised that this would be considered to be an informal competition – which would mean that as long as signed and dated attendance records for these players were kept – the organisers would be covered for liability cover re the actions of the non-members. The non members will not be covered for Personal Accident.

It is important to ensure that the tournament complies with the minimum Operating Standards as set out by England Netball on their website

5.2 Accounts / Membership

The Membership Secretary includes the membership figures in every committee meeting report. However there is still the issue of being able to find the full breakdown between clubs and schools and whether all members have linked to their local league and also to Norfolk County (The latter has an implication on whether the County are receiving all the money they should). This is an ongoing issue that the Executive Team are trying to resolve.

5.3 Committee

The action to ascertain if BTec students could take up one or more of the roles on the committee as part of their course was not pursued as the post was filled. Vacancies were published on social media platforms.

5.4 Juniors

It was noted that Helen Rowe was trying to establish a junior club but a CAPS accreditation was required. It was noted that the CAPS scheme is currently paused.

5.5 Coaching

Anne Harper confirmed that the level 2 coaching training course consists of three virtual sessions of three hours spread over three different dates. There are two days of face to face delivery and one virtual professional discussion on a different date, lasting for an hour.

6. TO RECEIVE AND ADOPT THE ANNUAL REPORT

The annual report was received and accepted. Proposed by Jill Masdin and seconded by Shelley James. All in favour.

The Chair added that the skills matrix regarding the required strengths and skills for the committee as set by EN was difficult to fulfil as the committee is run by volunteers.

7. TO RECEIVE AND ADOPT THE ACCOUNTS

The year end accounts were received and accepted. Proposed by Izzy Allison and seconded by Helen Rowe. All in favour.

The Treasurer stated that the year-end position is encouraging, up £2,000 from last year, due to funds received from the organised tournaments. The County has paid out £1,000 in funding support, and the school's affiliation has now been reconciled; £2,204 has been paid to schools. [NB: this figure included all payments from 2019 including 2024/25.] Funds have been transferred to the high interest account which should generate more income for the following year. Umpiring and mentoring fees have increased during the year and the cost of the NDO is increasing by 3.5%.

The main income is from the affiliation fees received from EN. At present, there is no easy mechanism to match the monies received with the listed number of members on the Engage system. This is an ongoing issue as previously noted in point 5.2.

The accounts will be examined by Accountants T C Farnell Clarke Ltd based at Icen Court, Norwich.

8. TO RECEIVE REPORTS

The reports by the County Committee members were received and accepted. Proposed by Sophie Pike and seconded by Jo Walton. All in favour.

9. AFFILIATION FEES

EN have now confirmed their increase in fees and affiliation is now

- Over 18 £41.30
- Under 18 £19.04
- Under 14 £10.20
- Under 11 £7.40

Unfortunately, these figures were released after the NCNA papers were published. The treasurer has reviewed the figures; taking in to account the increase in NDO fees and the difficulties trying to reconcile the membership data, and proposed an increase of 50p increase for the Over 18's. Therefore, the total fee for over 18's would rise £49.

It was noted that the East Region do not proposed to increase their fees this year.

Following a full debate a vote was taken and the motion carried to increase the fees to:

Proposed by Kerry Lincoln and seconded by Jon Webb. All in favour.

The Treasurer will update the EN website and these fees will be effective from 1st September 2025.

10. CONSTITUTION

Several minor grammatical changes had been put forward for approval. In addition, the wording of point 10; umpiring at County Events was amended:

Those umpires who wish to remain active at County events will be required to attend any refresher/update as defined by the County and hold a minimum C award qualification, ~~or a talent identified into~~ or a recommended progressing IOA.

Proposed by Sophie Pike and seconded by Jon Webb. All in favour.

It was noted that Paul Clark had reviewed the current County Constitution and had made some recommendations to bring it inline with the EN constitution. A working party will be formed post-AGM to review the suggestions and the final proposal will be submitted at the AGM 2026 for approval.

11. FUNDING

Several funding applications have been received and approved; individual requests and requests for equipment by groups (West Norfolk League and Norwich League). The application form is being updated. Any one wishing further information should contact the treasurer direct.
