



## Private Photo Session Contract

1. This photography session is between the Client, \_\_\_\_\_, and Photographer, Lauren Aston Photography, for the photo session detailed in the Private Photo Session Contract. Both the Client and Photographer agree to abide by the terms of this contract.
2. All images produced from this photo session remain the sole intellectual property of the Photographer and may not be reproduced or distributed in any way without previous written permission by the Photographer. Client may **share** social media posts created by the Photographer, but may not alter the images in any way, including removing the watermark applied by the Photographer.
3. Client agrees to pay the Photographer a non-refundable deposit at the time of booking in order to hold the session date/time and agrees to pay the remaining balance in full by the day of the photo session, as listed in the session details in this contract. Client also agrees to pay for any products, such as prints or digital images not included with the session, in full prior to delivery of said products, less any credit provided as part of the session package, as listed in the session details in this contract.
4. Client agrees that Photographer cannot guarantee certain poses and Client agrees not to hold the Photographer liable for compromised image quality due to lack of cooperation by image subjects or weather/lighting conditions.
5. Photographer will provide Client with image proofs via website link and/or proof prints, depending on session package, typically within one month. Client agrees not to hold the Photographer liable for any delay in delivery of proofs due to Photographer’s schedule.
6. Client agrees not to hold Photographer liable for any injury to persons or animals or damage to any property incurred during photo session, due to the unpredictable nature of animals. Photographer also agrees not to hold Client liable for any such injury or damage.
7. Client may postpone and reschedule photo session one time for any reason with 48hr notice and deposit will transfer to new date within 6 months. If Client chooses to cancel photo session or is unable to reschedule within 6 months, deposit will not be refunded. If Client postpones a second time, deposit may not be transferred or refunded, at Photographer’s discretion. If Client and Photographer mutually agree to postpone due to inclement weather, deposit will transfer to new date within 6 months. If Photographer must postpone for any reason other than inclement weather, Client may apply deposit to a new date within 1 year or may request a full refund of deposit.
