Indian River Farms Water Control District May 14, 2020

The regular monthly meeting of the Board of Supervisors was held in the office of the District in Vero Beach, Florida, Thursday, May 14, 2020, at 2:00 O'clock P.M.

We have four (4) Utility Construction Permit Applications for consideration at the regular scheduled May 14, 2020 board meeting.

(1) Request from Comcast to install by directional bore, a 2" conduit under existing culvert in Sublateral A-4-E (33rd Street) Canal within east right-of-way of Berkley Square Way (a/k/a 65th Way). RECOMMENDATION: We recommend approval of this permit subject to all applicable standard provisos, applicable special conditions.

(2) Request from Comcast to install buried cable over existing R.C.P. culvert in

North Dike Canal within west right-of-way of 74th Avenue.

RECOMMENDATION: We recommend approval of this permit application subject to all standard provisos and applicable special conditions.

(3) Request from FP&L to provide underground electrical conduit, under Lundberg Road, from existing power poles located within Main Canal right-of-way.

RECOMMENDATION: We recommend approval of this permit application subject to all standard provisos and applicable special conditions.

(4) Request from FP&L to upgrade existing aerial crossing of Main Canal within east right-of-way of 43rd Avenue.

RECOMMENDATION: We recommend approval of this permit application subject to all standard provisos and applicable special conditions.

On a motion made by Supervisor Barker and second by Supervisor Tripson the above permits were approved.

We have one (1) Permit Application request from the Indian River County Public Works, through Kimley Horn, the Engineering Consultants for the County to replace the 58th Avenue bridge over the North Relief Canal with a 42 foot wide Conspan Structure.

RECOMMENDATION: CAI cannot recommend approval of this permit request since the calculated hydraulic head loss through the 42 foot Conspan is 0.16 foot. The IRFWCD policy requires no more than 0.10 foot of head loss for any proposed structure in the District canal system. A 48 foot span would reduce the head loss to 0.12 foot and would be much closer to the policy requirements, therefore CAI would recommend approval of a variance for the 48 foot Conspan.

DISCUSSION:

Rich Szpyrka, Indian River County Public Works Director, requested the Board to consider the approval of the 42 foot Conspan due to an estimated increase in cost of \$500,000 to provide the 48 foot Conspan. The Board asked if there were any other Conspans being considered by the County. Rich Szpyrka responded no, three other new canal crossings are currently in design and they are all proposed bridges.

On a motion duly made, put and unanimously carried, Board approved the variance for the 42 foot Conspan with the applicable standard provisos, and applicable special conditions.

On a motion duly made, put and unanimously carried, Carter Associates, Inc. District's Surveyor and Engineer monthly retainer fee increased to \$650.00.

On a motion duly made, put and unanimously carried, the law firm of O'Haire, Quinn, Chartered; Legal counsel for the District monthly retainer fee increased to \$650.00.

On a motion duly made, put and unanimously carried, Superintendent David E. Gunter will receive \$1077.00 monthly for vehicle allowance.

Superintendent Gunter reported recent increase in corrugated metal pipe failures in sections of the District's canal system. The pipe failures due to corrosion and metal loss are in installations only 20 to 30 years old and cause significant impacts to drainage service. Repair costs are especially high if the pipe failure is under a public roadway or private road/driveway with expensive headwall, signs, paver, etc. type embellishments. These failures usually present an unexpected and unbudgeted expense for the responsible maintenance entity which may cause delays in funding the repairs. After much discussion it is recommended RCP pipe material 100 year service life be used in all District canals under County or City roads.

Secretary Gunter requested the Board's recommendation and asked that a resolution for Board policy be made at this time.

At this regular meeting of the Board of Supervisors of the Indian River Farms Water Control District held on May 14, 2020, the following resolutions were unanimously adopted by the Board:

RESOLUTION

WHEREAS, On motion by Supervisor Tripson and unanimously passed, as a matter of policy, going forward, the following shall be the operative regulation with respect to pipe material in all District canals under County or City roads east of 66th Avenue

RESOLVED that, in all District canals under County or City roads east of 66th Avenue, RCP pipe material 100 year service life will be required.
