The information received from the credit bureaus will help us to continue the dispute process. Failure to contact us promptly will result in delay or non-completion of your credit repair.

FAILURE TO COMPLY WITHIN 90 DAYS WITH LETTERS FROM CREDIT BUREAU'S WILL RESULT IN TERMINATION OF THIS CONTRACT.

It is the customer obligation not to apply for new credit while GSCR is in process of disputing and resolving disputed items on your credit report. By applying for new credit, it will negate the progress that we have made.
