



AESTHETICS MEMBERSHIP AGREEMENT

This Membership Agreement ("Agreement") is entered into between the undersigned client ("Client") and LifeWay Health & Wellness ("LifeWay") for the provision of aesthetics services, subject to the terms and conditions outlined below:

MONTHLY MEMBERSHIP FEE:

- Client agrees to pay a one-time sign-up fee of \$40 upon enrollment.
- Client will be charged a monthly fee, as outlined in Appendix A, based on the selected membership level.
- In accordance with our membership agreement, please be advised that there is a possibility of annual fee increases. We commit to notifying you at least 30 days in advance of any such adjustments. Additionally, we value your flexibility, and you have the right to cancel your membership in the event of a fee increase.

MEMBERSHIP DURATION:

- Client commits to a minimum of 3 months.
- After the initial 3 months, the client may cancel/pause anytime with a 30-day notice.

UNUSED MONTHS:

- Unused months' fees/treatment fees will be banked and can be applied to any services. *Except where noted under Ruby Radiant level.
- Banked fees do not expire unless the contract is canceled, in which case the client has 6 months to use the banked fees. After 6 months from cancellation, the banked fees will not be refunded.
- Banked fees are not transferable.

MEMBERSHIP HOLD:

- Client may put the contract on hold for a maximum of 3 months.
- Once the 3 months has been completed, the client's credit card will begin to be charged again as per the agreement.
- pausing/hold membership is a great time to catch up and use any/all banked treatments.



PAYMENT METHOD:

- A valid credit card must be kept on file for monthly charges.
- In the event of a failed payment, the client will be notified.
- The client has 24 hours to pay; failure to do so may result in a \$25 charge and possible contract cancellation, losing all banked fees.

MEMBERSHIP CHANGES:

- We understand that your needs may evolve, so you have the option to adjust your membership level with a 30 day notice at any time. Whether you choose to upgrade or downgrade, we are committed to accommodating your preferences to ensure a seamless experience with LifeWay Health & Wellness.
- The client will not lose any banked fees when changing levels.
