3. CLIENT RESPONSIBILITIES

The Client agrees to:

- Treat Provider's vehicles and drivers with respect and adhere to all safety instructions.
- Assume liability for any damages beyond normal wear and tear incurred during Client use.

- Client acknowledges responsibility to indemnify and hold harmless Aegis Executive Transport, LLC from any claims arising from Client's actions, negligence, or misconduct during service.
- Provider shall not be held liable for delays, cancellations, or damages resulting from unforeseen circumstances, including traffic, weather, or third-party interference.
- Provider's liability shall be limited to the total service fees paid by Client under this Agreement.

7. CONFIDENTIALITY & NON-COMPETE

- Both parties agree to maintain confidentiality regarding client itineraries, security measures, and any sensitive information disclosed.
- The Client shall not solicit the services of Provider's employees or subcontractors for a period of one (1) year after the completion of this Agreement.

8. CANCELLATION & TERMINATION

- Client may cancel services with at least 24 hours' notice to avoid cancellation fees.
- Provider reserves the right to terminate service immediately for misconduct, safety concerns, or breach of agreement.
- Any cancellations made less than 24 hours before service will be subject to a cancellation fee equal to 50% of the agreed-upon rate.

9. GOVERNING LAW & DISPUTE RESOLUTION

- This Agreement shall be governed by the laws of the State of Maryland.
- Any disputes shall be resolved through binding arbitration in Baltimore, Maryland.
