4. Interested parties

All written representations will be taken into account regardless of attendance at the inquiry. The Rule 6 party represents local residents in the Bearwood and Merley Ward and there will be no need for individuals to repeat the Rule 6 case or that of the Council. No new evidence should be produced.

The Planning Inspectorate's Procedure Guide advises that if a person wishes to speak at the inquiry they should be there when the inquiry opens to register their names. If it is not possible to stay until after opening submissions to speak (as currently indicated in the programme) an alternative arrangement may be possible. As it stands no evening sessions are planned.

7. Accompanied site visit(s)

The visit is an integral part of the inquiry and certainly should take place before the closing submissions. The visit is likely to centre on (i) the appeal site and immediate surroundings, (ii) heritage assets and scheduled monuments, and (iii) views and landscape. There may be merit in having shorter, focused visits than everything all in a single day.



Members of the public may attend the Inquiry and, at the Inspector's discretion, express their views.
