2. _____ I understand my pet will only be released to me or to an agent I authorized in writing. My pet will be released during normal office hours. **Please review office hours.** All charges incurred will be paid in full prior to, or upon pick up. Please **make sure** North Main Pet Lodge has the name of all persons (family members or others) authorized to pick up your pet. 3. _____ I certify my pet is fully vaccinated in accordance with the vaccine policy of North Main Pet Lodge and is in good health and has not been exposed to rabies, distemper or any other communicable diseases with in the last 30 days.

5. _____ I understand that my pet will be checked for fleas and ticks and if found, I will be notified, my pet will be bathed and I agree to pay the bathing fee.

7. _____ I understand my pet must be brought in and out of the Pet Lodge on a leash.

8. _____ I agree to pay all costs for any property damage, personal injury or animal injury caused by my pet during its stay.

9. _____ I understand attendance in daycare, overnight lodging, group play, and walks off site, is not without risk to my pet. The North Main Pet Lodge agrees to exercise and all due and reasonable care to prevent injury, illness or loss of my pet. However, in the event of illness, injury or loss the owner and employees of North Main Pet Lodge shall not be held personally liable for such injury, illness or loss. Furthermore, if I have elected group play, I understand that abrasions, nicks, scratches or mucous is a normal consequence of canine play and interacting with other dogs, and I will not hold the North Main Pet Lodge responsible for such wounds or injuries.

10. _____ I hereby grant permission of North Main Pet Lodge to act on my behalf, and in my pet's best interest, by obtaining veterinary care at my expense, if deemed necessary, for illness or injury. I further agree to pay for all veterinary and other necessary services incurred by and for my pet during its stay. **North Main Pet Lodge will make every effort to contact me and/or my designated emergency contact, however if time does not permit, or the North Main Pet Lodge is unable to reach me or my designated emergency contact, and veterinary care is urgently needed,** would you like to put a Vet cost limit on your pet?
