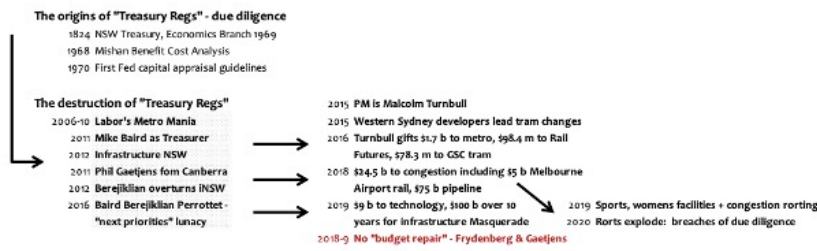

NSW and Morrison are lurching from blundering, failing, dissembling, patching-up and panicking
