4. STONEHINGE MONUMENTS

- Discussed landscaping, seasonal decorations and repair
- Board gave the Cheeks and Russells permission to clean up landscaping by removing dead trees and making landscaping more consistent between the monuments.
- Board will reimburse any landscaping expenses and will include maintenance in future budgets.
- Board requested notice before any decorations were placed on the monuments or more elaborate landscaping was completed.
- Board went and surveyed the repair needs of monuments. Upon inspection, it
 was decided that the existing brick was in decent shape, but the stone pillars and
 border were in disrepair.
- Treasurer will coordinate with other board members to resource contractors and get estimates to repair or replace the stone elements and the long-term maintenance needs of each option. After estimates are gathered, Treasurer will evaluate options for covering costs. The board will review at July meeting.
- Board to confirm neighborhood property lines to ensure monument on the corner of FR 129 and FR 146 is within the POA's jurisdiction.

• The goal is to present restoration options to the membership to vote on at the annual meeting.
