This Puppy Adoption Contract legally binds the Breeder and the Purchaser under the following conditions:

Health and Background

The Breeder has ensured that the sire and dam are sound breeding stock. The puppies have been reared in a home environment and have been thoroughly wormed. The puppy is believed to be in good health.

Veterinary Check

The Purchaser is strongly advised to have the puppy vet-checked within five (5) days of collecting the puppy. If the vet certifies that there is any problem making the puppy unfit for sale, provided the puppy is returned in the same condition as when it was sold and within seven days, the Breeder will take the puppy back and refund the full purchase price. The Breeder will not pay expenses incurred in the return of the puppy nor accept any claims for distress caused by the return.

Veterinary Bills and Liability

The Breeder is not responsible for any veterinary bills incurred after the puppy leaves the care of Summer Sun Doodles and shall not be responsible for injury caused by carelessness or negligence on the part of the Purchaser.

Limitations of Guarantee

The Breeder makes no guarantees regarding the loss of the puppy due to accidental death, theft, sickness due to lack of vaccinations, or any other loss beyond the control of the Breeder, except as stated above.

Purchaser's Experience

The Breeder has inquired about the Purchaser's past experience with dogs and this particular breed. Based on the information received, the Breeder is willing to place a puppy with the Purchaser. The Breeder has pointed out the main conditions the breed is prone to and the health schemes followed to reduce the risk of such conditions. Every puppy is an individual, and the Breeder cannot be held responsible should conditions, genetic or otherwise, develop later in life.

Welfare and Care

The Purchaser agrees that the dog will be kept in appropriate conditions for its welfare and health. It will be fed a suitable diet for its age and condition and receive appropriate exercise. The dog will receive all necessary veterinary care to maintain its physical good health and will be kept under appropriate control, not neglected or maltreated in any way. The Purchaser attests that he or she has not been banned from keeping a dog or any other animal by any legal court.

Re-homing Conditions

If the Purchaser is unable or unwilling to care for the puppy at any point during their lifespan, they must notify the Breeder in writing. The Breeder has the first right of refusal to reacquire the puppy at no cost within 7 business days. If this right is exercised, the Purchaser must provide veterinary records, complete microchip documents and cover transportation costs to the Breeder. If the Breeder does not exercise this right within the specified timeframe, the Buyer may rehome the puppy but must inform the Breeder of the new owner's contact information and cannot abandon or resell the puppy without the Breeder's consent. No refund is guaranteed.



Use of Images

The Purchaser allows Summer Sun Doodles to use any pictures of the dog that he/she posts on social media in any manner they choose, generally by reposting and sharing on Facebook, Instagram, etc.

Mediation Clause

In the event of any dispute arising out of or relating to this contract, the parties agree to attempt to resolve the dispute through mediation before resorting to legal action. The mediation shall be conducted in accordance with the rules of a mutually agreed-upon mediation service. If the parties cannot agree on a mediation service, the mediation shall be conducted through the American Arbitration Association. Mediation fees, if any, shall be divided equally between the two parties.

Acknowledgment

I acknowledge that this is a legal and binding contract and have reviewed and agree to the terms listed above. The Purchaser agrees to maintain up-to-date vaccines, wormings, heartworm prevention, and to keep the puppy/dog in humane conditions, providing proper food, water, and shelter. Failure to follow the above conditions will result in a breach of contract and shall render the contract null and void. This contract applies only to the original Purchaser and is NOT transferable. By paying a reservation fee to Summer Sun Doodles, the Purchaser automatically agrees to the terms of this contract, even if both parties have not yet signed.

10 YEAR HEALTH GUARANTEE

This health guarantee applies to all puppies bred or sold by Summer Sun Doodles, California City, CA, USA.

Health Check Policy

Before your puppy is sent home, he or she undergoes an extensive veterinary health check, and all vaccination and deworming protocols are followed to ensure your puppy arrives healthy and happy.

YOUR OBLIGATIONS

You must fulfill these obligations, or this Health Guarantee will terminate and become null and void:

- **Veterinary Examination:** You must have your puppy examined by a licensed veterinarian within five (5) business days of receipt. Regular veterinary visits (at least once a year) are required.
- **Vaccination Guidelines:** Your puppy comes with up-to-date vaccinations. Do not vaccinate the puppy within the first ten (10) days to avoid over-vaccination.
- **Exercise:** Do not over-exercise your dog during its growth period.
- **Spay/Neuter Policy:** The dog must be spayed or neutered no earlier than 8 months of age but no later than 24 months of age. These dogs are intended as companion animals; breeding is not allowed. If breeding rights are sold, the dog will not be covered for reproductive issues.

TERMS AND CONDITIONS OF HEALTH GUARANTEE

These terms apply only to puppies bred at Summer Sun Doodles, California City, CA, USA.

- **Year 1-2:** If within two (2) years from the date of purchase, a dog is certified by two (2) licensed veterinarians of the Purchaser's choosing to have a life-threatening congenital or hereditary condition, and if the breeder is notified within five (5) business days of the first determination, the breeder will provide a replacement puppy. The breeder reserves the right to obtain a third opinion to determine the condition.
- **Years 3-10:** If, between the second (2nd) and tenth (10th) anniversary of the purchase, a dog is found to have a life-threatening congenital or hereditary condition, and if the breeder is notified within five (5) business days, the breeder shall issue a credit of 50% of the original purchase price toward a replacement puppy. The breeder reserves the right to obtain a third opinion.
- **Definitions:** A congenital defect is a problem that prevents the puppy from growing to a normal life expectancy. Conditions like bone joint issues, luxating patella, going blind, being deaf, hernias, or limps are not considered life-threatening. Major organ failures (heart, lungs, liver, etc.) are covered. This warranty does not include viral illnesses, infections, improper bites, stress-related illnesses, hernias, hypoglycemia, parasites, or illnesses due to foreign object ingestion.
- **Veterinary Costs:** Veterinary costs are not covered by the breeder.

Purchaser Acknowledgments

The Purchaser acknowledges that owning a puppy requires regular veterinary visits (at least once a year) and is responsible for all associated costs, including spaying or neutering. Failure to provide timely vaccinations or regular care will void this Health Guarantee. Following a recommended nutritional program and avoiding over-exercising during growth is essential.

Summer Sun Doodles requires that each puppy has activated at least 30 days of coverage through Trupanion within 24 hours of receipt. Ongoing health insurance for at least the first two years (lifetime is preferable) is highly recommended.

The Purchaser will provide adequate housing, keeping the dog primarily indoors with the family. Goldendoodles are social animals and should not be left outside for long periods, especially in extreme temperatures. The Purchaser will ensure the dog receives monthly heartworm prevention and flea control during warmer months or annual heartworm checks.

The Purchaser agrees to maintain the puppy at a healthy weight. The warranty will terminate if the dog becomes overweight or if developing joints are overstressed within the first two years. Consult your veterinarian with any questions.

Spay/Neuter Proof: The dog must be spayed or neutered no earlier than 8 months of age and no later than 24 months of age, and proof must be submitted through SpaySecure. If credible proof is not provided within this timeframe, the breeder is entitled to \$6,000 in damages.

Temperament issues are not covered under this Health Guarantee.

In addition to all conditions in this agreement, the following must be met, or this Health Guarantee will terminate:

- The Purchaser must sign a Veterinarian Medical Records Release Form and have the puppy examined by a licensed DVM within five (5) business days. A copy of the examination must be sent to Summer Sun Doodles within five (5) days. Failure to comply will void this Health Guarantee.
- If the Purchaser declines any replacement puppy, the breeder is released from all further claims.
- This Health Guarantee will terminate if the Purchaser fails to comply with care, maintenance, or medical treatment terms, or any terms in the Puppy Adoption Contract.
- The value of the puppy for this Health Guarantee is limited to the purchase price and does not include additional costs. This Health Guarantee is non-transferable.
