

10 YEAR HEALTH GUARANTEE



This health quarantee now applies to all Puppies bred or sold by Summer Sun Doodles, Mary Esther, FL, USA.

Health Check Policy — Before your puppy is sent home to you, he or she has undergone an extensive veterinary health check and all vaccination and deworming protocols have been followed to ensure your puppy arrives healthy and happy.

Year 1-2 Health Guarantee — If, within two years of purchase, your puppy is found to have a life threatening congenital or hereditary condition, we will provide you with a replacement puppy of equivalent value.

Years 3-10 Health Guarantee — If, after the second year, but before the tenth anniversary of your purchase, your puppy is found to have a congenital or hereditary condition which adversely affects your puppy's health, we will offer you a credit of 50% of your purchase price towards the purchase of another puppy from us.

YOUR OBLIGATIONS

You must fulfill these obligations, as explained herein, or this Health Guarantee will terminate and become null and void!

- You must have your puppy examined by a licensed veterinarian within three (3) business days of receipt of the puppy and, to ensure the health of your dog, you must visit the veterinarian on a regular basis, at least once a year, ensuring your dog receives proper health checkups and timely inoculations.
- Your puppy comes with up-to-date vaccinations. You therefore should not vaccinate the puppy within the first ten (10) days of receiving the puppy to avoid over vaccination.
- Do not over-exercise your dog during his or her growth period.
- These dogs are intended to be companion dogs; do not breed your dog. Should breeding rights be sold the dog will not be covered for reproductive issues.

TERMS AND CONDITIONS OF HEALTH GUARANTEE

These terms and conditions only apply to Puppies bred at Summer Sun Doodles, Fort Walton Beach, FL, USA.

Year 1-2: If within two (2) years from the date of purchase from Seller, a dog is found and certified by two (2) duly licensed Doctor of Veterinary Medicine (DVMs) of Purchaser's choosing to have a life threatening congenital or hereditary condition, and if Seller is notified within five (5) business days of the first veterinarian's determination, the Seller will provide a replacement puppy of equivalent value. Seller reserves the right to obtain a third opinion of Seller's choosing to determine the life threatening congenital or hereditary condition. All laboratory verification must be done by a licensed DVM.

Years 3-10: If, between the second (2nd) and tenth (10th) anniversary of the date of purchase from Seller, a dog is found and certified by two (2) duly licensed DVMs of Purchaser's choosing to have a life threatening congenital or hereditary condition, and if Seller is notified within five (5) business days of the first veterinarian's determination, the Seller shall issue a credit in the amount of fifty percent (50%) of the purchase price of the dog towards the purchase of a replacement puppy from Seller. Seller reserves the right to obtain a third opinion of Seller's choosing to determine the life threatening congenital or hereditary condition.

should breeding rights be sold the dog will not be covered for reproductive issues. However, we will replace breeding dog at no additional cost if they happen to have any abnormal OFA health examinations or score below a "fair" for OFA hip certification. Delivery fees are not included..

A congenital defect is a problem that will not allow the pup to grow to a normal life expectancy. A bone joint issue, luxating patella, going blind, being deaf, having a hernia, or having a limp is not considered life threatening. A major body organ that sustains life going bad (heart, lungs, liver, etc.) is considered a congenital defect and is covered. Health problems that can be cured by medication or surgery are not covered.

This warranty does not include viral illnesses, infections, improper bites, stress related illness, hernias, hypoglycemia, parasites, or worms (including Giardia or Coccidiosis), cancer, or endocrine disorders. It also does not include any illness due to the ingestion of foreign objects, food, chemicals, or physical injury.

Veterinary Costs: Veterinary costs are not covered by Seller.

Purchaser Acknowledgments: Purchaser is aware that owning a puppy means frequent visits to a licensed DVM (at least once a year) and understands that he/she will be responsible for all costs associated with all veterinarian visits, such as but not limited to any veterinarian costs associated with spaying or neutering, including undescended testes. Failure of the Purchaser to provide puppy with timely inoculations or regular (at least once a year) veterinary care will void this Health Guarantee. Purchasers should follow a recommended nutritional program, including feeding only premium dog foods and vitamin supplements such as Diamond Naturals. The dog should not be over exercised during their growth period.

Summer Sun Doodles' policy is that each puppy must have activated at least the 30-day coverage through Trupanion within 24 hours of receiving your puppy. Ongoing health insurance for at least the first 2 years (lifetime is preferable) is highly recommended. Poodle and Doodle Haven partners with Trupanion, which offers a complimentary 30-day coverage at no cost to the purchaser.

Purchaser will provide adequate housing for the dog away from the elements. The dog will be kept primarily inside with the family. Doodles are very social animals and thrive on the love and attention of their owners. A Doodle left alone for long periods of time could develop bad habits out of boredom and loneliness. This puppy will not be left outside for longer than an hour at a time when temperatures are over 80 degrees unless puppy is with people and they are making adequate arrangements to keep the dog cool.

Purchaser will make sure puppy/adult dog receives monthly heartworm preventative and flea control at least every 45 days during the warmer months OR will have dog checked for heartworms every year. If Buyer lives in a state that does not need this preventative care, yearly checkups are still required.

Purchaser agrees to maintain the puppy at a good healthy weight. This warranty will be terminated should the dog be allowed to become overweight or developing joints be overstressed at any point during the first two years. Consult your veterinarian with any questions.

Seller sells pets for companion purposes only. The dog must be spayed and neutered within 18 months of age but no earlier than 8 months of age. If credible written proof is not given within 18 months to seller of the spay or neuter the seller is entitled to \$20,000 in damages. If your dog is bred, this Health Guarantee shall terminate and become null and void. Temperament issues are not covered under this Health Guarantee as they can be caused by several factors outside control of Seller including, without limitation, lack of training, discipline, or proper dog socialization. The owner is responsible for all transportation costs to and from the Seller.

In addition to all the conditions set forth in this agreement, the following additional conditions shall apply and must be met, or this Health Guarantee shall terminate and become null and void:

- The Purchaser must sign a Veterinarian Medical Records Release Form and have the puppy examined by a licensed DVM within three (3) business days of receipt of the puppy, for the puppy's New Puppy Examination (NPE). A copy of the examination (medical record) for the NPE must be sent to Summer Sun Doodles by e-mail (lankford_summer@yahoo.com) or mailed to Summer Sun Doodles, 310 Evergreen Dr, Mary Esther, FL 32569, within seven (7) days of receipt of the puppy. The Purchaser shall not vaccinate the puppy within the first ten (10) days of receiving the puppy. Failure of the Purchaser to comply with the provisions of this sub-part (i) shall void this Health Guarantee.
- If the Purchaser declines any replacement puppy, then the Seller shall be under no further obligation, and it shall be deemed that the Purchaser has released the Seller from all further claims and waived any rights to pursue any claims against the Seller.
- This Health Guarantee shall terminate and become null and void if the Purchaser fails to comply with any term in this Agreement regarding the care, maintenance, or medical treatments or procedures that the Purchaser is responsible for providing to the puppy. This Health Guarantee shall also terminate and become null and void if the Purchaser fails to comply with any term in the Puppy Adoption Contract.
- The value of the puppy for purposes of this Health Guarantee is limited to the Purchase Price of the puppy, and does
 not include taxes, shipping, health certificate and veterinarian costs, shipping crate or any additional costs or
 expenses incurred or asserted by the Purchaser. This Health Guarantee is non-transferable and is not valid for sales
 of any puppies delivered outside the United States.
