Welcome to Our Program!

This Guardian-Home Program has been established to enhance our breeding program while ensuring that each of our breeding dogs is placed in a nurturing environment within a guardian family. By entering into this Agreement, you agree to serve as a guardian for a dog designated as either a female potential or proven breeder, or a male potential or proven breeder ("the Dog"), in accordance with the terms outlined herein.

1. Benefits of the Guardian-Home Program

To the Guardian family:

The Dog is considered "pick of the litter," with an estimated value of \$10,000 to \$15,000. Your initial cost is \$0. All veterinary costs related to health testing for breeding purposes will be covered by the Breeder.





As a participant in the Guardian-Home Program, you agree to:

- 1. Reside within a two-hour radius of California City, California.
- Own your home or possess written consent from your landlord to keep a dog.
- 3. Provide physical fencing to ensure a safe and secure environment for the Dog, preventing unplanned pregnancies.
- 4. Never allow the Dog to be off-leash in unsecured areas; dog parks are prohibited.
- 5. Maintain reliable transportation and be available to bring the Dog to the Breeder as needed for breeding-related activities, including health testing and whelping. All breeding-related veterinary care will be conducted by an approved veterinarian, at the Breeder's expense.
- 6. Maintain open communication with the Breeder regarding all matters concerning the Dog.
- 7. Feed the Dog Open Farm dog food or Just Food For Dogs unless otherwise approved by the Breeder. Ensure the Dog is on a monthly heartworm, flea, and tick prevention program. Regular grooming (every 4–8 weeks) is required.
- 8. Acknowledge that the Breeder may make decisions concerning the Dog's welfare, including but not limited to additional veterinary care; all decisions will be made in the Dog's best interest.
- 9. Grant Summer Sun Doodles permission to use your name in all publications, including websites and promotional materials.

3. Ownership

Ownership of the Dog, including all rights, title, and interest, shall remain with the Breeder. For female Dogs, all puppies produced will be the sole property of the Breeder. The Guardian Family will have no ownership interest in any such puppies. For male Dogs, all semen shall remain the sole property of the Breeder, and the Guardian Family shall have no rights to its use. The Dog will be utilized exclusively for breeding as directed by the Breeder. Upon the Dog's retirement from breeding, ownership will be transferred to the Guardian Family via written documentation, contingent upon spaying or neutering.

4. Possession

Upon execution of this Agreement, possession of the Dog will be transferred to the Guardian Family. The Guardian Family shall retain possession of the Dog during the term of this Agreement, subject to the obligations to return the Dog for breeding purposes, while providing care and supervision in accordance with the terms herein.



5. Breeding Requirements

Female Dogs:

The Breeder requires access to the female breeding Dog for the following purposes:

- 1. Veterinary appointments for general health checks and pregnancy monitoring (approximately two visits
- 2. Breeding activities occurring 6-8 days after the first signs of heat until successful mating (typically 6-9 days). The Guardian Family may bring the Dog to the Breeder every other day or leave her for the duration of the breeding process, as determined by the Breeder.
- 3. Whelping, which includes the period 7-14 days prior to the Dog's due date and continuing until the puppies are weaned (approximately 6 weeks after birth).

Male Dogs:

The Breeder requires access to the male breeding Dog for the following reasons:

1. The male must be available for breeding on short notice, typically within 3-10 days. Occasionally, last-minute requirements may arise with less than 48 hours' notice. The Guardian Family may bring the Dog to the Breeder or arrange for frozen semen shipment as necessary.

Additional provisions:

- The Guardian Family shall not transfer possession of the Dog to any third party without prior written consent from the Breeder.
- The Breeder reserves the right to visit the Guardian Family's residence at least once per calendar year to discuss the Dog's care.
- Female Dogs will not be bred more than four times, subject to the Breeder's discretion.
- Males will not be bred after 7 years of age.
- In the event of communication difficulties with the Guardian Family that create a hostile relationship, the Breeder retains the right to reclaim the Dog.
- Females MAY NOT live in guardian homes with INTACT MALES and MAY NOT be bred to males who have not been approved and arranged by us.
- Males MAY NOT live in guardian homes with INTACT FEMALES and MAY NOT be bred to females who have not been approved and arranged by us. This is to ensure the health of the male and avoid contracting canine brucellosis, a contagious bacterial infection. Infected dogs usually develop an infection of the reproductive system, or a sexually transmitted disease and must be euthanized.

6. Guardian Family Obligations

The Guardian Family agrees to:

- 1. Raise the Dog as an indoor pet; outdoor dwelling is prohibited.
- 2. Securely contain the Dog indoors when left alone (a kennel is preferred).
- 3. Comply with the Breeder's nutritional and dietary guidelines and bear all expenses related to feeding the Dog.
- 4. Provide regular exercise and socialization with people and only spayed or neutered dogs.
- 5. Utilize Dill Veterinary Hospital at 11207 San Fernando Road, San Fernando, CA 91340 as the Dog's veterinary care provider, except in emergencies.
- 6. Provide monthly updates and photographs of the Dog.



- 7. . Schedule and pay for all veterinary appointments unrelated to breeding and provide routine medical care.
- 8. Ensure the Dog remains compliant, kennel-trained, housebroken, and leash-trained.
- 9. Notify the Breeder of any planned vacations or changes in address, phone number, or email. The Dog shall not be placed in aboarding kennel without the Breeder's prior approval.
- 10. Provide photographs of the Dog upon request from the Breeder.
- 11. Acknowledge that the Guardian Dog represents a financial investment by the Breeder. Any violations or negligence impacting the Dog's breeding capabilities may result in a penalty fee of \$5,000.
- 12. Understand that if the Dog is altered or bred without the Breeder's written consent, the Guardian Family will be liable for \$20,000, along with any legal costs incurred in pursuing this payment.

7. Termination of Agreement

This Agreement shall terminate upon any of the following occurrences:

- 1. Upon transfer of ownership of the Dog to the Guardian Family.
- 2. Upon the Breeder's determination that the Guardian Family has breached the terms of this Agreement, posing a significant risk to the Dog's health, welfare, and safety.
- 3. Upon the Dog's death due to natural or accidental causes.
- 4. Upon the Guardian Family's permanent return of the Dog to the Breeder for any reason.

8. Indemnity

The Guardian Family agrees to indemnify and hold the Breeder harmless from all claims, liabilities, losses, costs, damages, and expenses arising from any property damage or injury or death to individuals allegedly caused by the Dog while in the possession of the Guardian Family.

Guardian Family Obligations

- 1. Raise the dog as an indoor dog. Never to dwell outside.
- 2. When left at home, safely contain the dog indoors (a kennel is preferred).
- 3. Comply with Owner's nutritional and dietary guidelines and pay all cost and expenses associated with feeding the dog.
- 4. Provide the Dog with regular exercise and socialization (people, locations and only spayed or neutered dogs).
- 5. **Wynn Haven or Hillman** are the only vets the Dog will see, unless there is an emergency and that is not an option. The Guardian Family can decide which one is more convenient for them.
- 6. Provide pictures and updates every month.
- 7. Schedule and pay for all veterinary appointments (other than those associated with breeding, which will be covered by the Owner) and provide routine medical care appropriate for the breeding Dog.
- 8. Continue to ensure the dog is compliant, kennel-trained, housebroken, and leash-trained. The Dog's puppies' safety relies on calm and focused behavior.
- 9. Notify the Owner of any planned vacations and change of address, phone or email. The dog will never dwell in a boarding kennel without approval of the Owner/Breeder.
- 10. Provide photos of the Dog when requested by the Owner.
- 11. Understand the guardian dog is also financial investment we are placing in your care. Any violation of the above or negligence on your part that affects the dog's ability to breed could result in a \$5,000 penalty fee owed to us.
- 12. If the dog is altered OR bred without written consent of the breeder, guardian will owe breeder a sum of \$20,000. Any legal costs involved with obtaining this payment will also be paid by guardian.

Termination of Agreement

This Agreement shall terminate upon the occurrence of any of the following:

- 1. Immediately, upon the transfer of ownership of the Dog to the Guardian Family
- 2. Immediately, upon Owner's determination that the Guardian Family is non-compliant with the terms of this Agreement and such non-compliance poses significant risk to the health, welfare and safety of the Dog, at which time possession of the Dog returns to the Owner.
- 3. Immediately, upon the death of the dog from natural or accidental causes.
- 4. Immediately, upon the Guardian Family's permanent return of the Dog to the Owner for any reason.

Indemnity

The Guardian Family agrees to indemnify and hold the Owner harmless from and against all claims, liabilities, losses, cost, damages and expenses by reason of any damage property or injury or death to individuals allegedly caused by the Dog while in the possession of the Guardian Family.
