\$120 (cash) per Tarot session (1 hour). Check in at the counter upon arrival.

\$30 per 15-minute increment for extended sessions (in the event there's an available time interval prior to the next scheduled appointment).

### **Each one (1) hour session features a pair of Tarot readings;**

- A. To optimize session time, the client is asked to prepare an "Outcome Question" prior to commencement of the session. When utilizing the Seven (7) Card Celtic Tarot Spread (as presented on page 1 herein), essentially, these randomly drawn cards are positioned to indicate key factors that collectively disclose the outcome (feasibility and achievability) of a desired *righteous* goal the client seeks to gain. Within the question, the client may also wish to include an *action strategy* by which the outcome/goal is to be attained (see the various formats for devising & constructing an "Outcome Question" – as exhibited on page 2 herein). The specific query may be held in confidence or shared with the Reader. In either case, it is imperative to commit the question to writing or voice recording beforehand. - B. A "General Positional Reading" is delivered – revealing the client's *present psychological and external environmental conditions*, and is augmented by *future phase projections* related to his/her evolving events. As catalyzed via the Nine (9) Card Celtic Tarot Spread, this reading spans the spectrum of "*now.*"

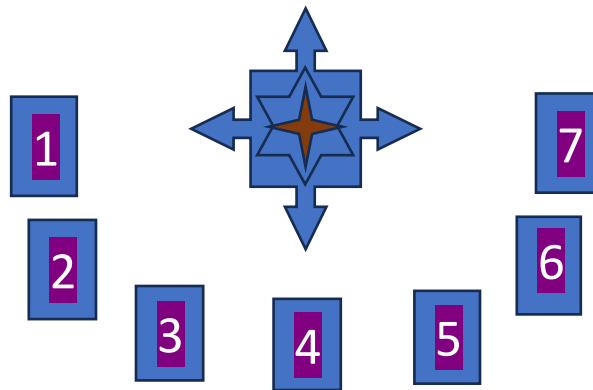


# The Seven (7) Card Celtic Tarot Spread

(Guide and Card Layout for Forecasting the Answer to an “*Outcome Question*”)

In order to interpret the questioner’s set of cards drawn from the deck, the Celts assigned a meaning to each card’s position. The meaning of each placement is as follows:

- 1) The past that has brought things to the present
- 2) The present
- 3) The general future conditions
- 4) The best policy to follow under the circumstances
- 5) The outside views...the opinion of others toward the situation (optional for consideration)
- 6) That which aids or hinders the outcome
- 7) The outcome (the forecasted result)...that which pertains to the foundational question



\* Prior to the session, carefully read and absorb the following directives:

- Upon composing a question, be sure to record it in writing or by utilizing a voice recorder.
- Formulate a question that focuses upon a particular goal or outcome you endeavor to attain/procure. For example; **“What will be the outcome if I seek to achieve ‘such and such’ ?”**
- With the question previously formulated and recorded, while *keeping all cards upright* (not upside down), begin shuffling (mixing up) the cards thoroughly. During the shuffling of the deck, it’s best to concentrate solely upon the question you have composed. That is, shuffle your question into the cards.
- Upon deeming them to be sufficiently randomly mixed and infused with the question at hand, cut the cards by splitting up the deck into three (3) separate stacks. Then, in non-reverse order, reconstitute them into a single stack. Again, each card in the deck must be kept upright (no reversed cards).
- Begin laying out each of seven upright cards (face down) according to the order (1 through 7) as depicted in the diagrammatic pattern above.

*With all cards dispensed in their proper positions (1 – 7), the interpretive procedure shall begin—turning each card over to progressively reveal details of the situation under question.*

## **Additional Considerations to Aid the Formulation of the “Outcome Question”**

The essence of an effective “outcome question” is the questioner’s chosen goal. This can take a myriad of forms, as can the applied means to attain it. Thus, the 7-Card Celtic Spread can provide the questioner with straightforward illumination of an auspicious outcome, or conversely, the card reading’s outcome may perhaps provide a timely forewarning that the envisioned objective entails impediments.

Examples of effectual “outcome questions” are as follows:

- a) *“What will be the outcome if I apply for a position with (insert) corporation?” or;*
- b) *“What will be the outcome if I take my cousin’s advice and travel with his friend, (insert name), to Denver to explore the region’s universities.” or;*
- c) *“What will be the outcome for my daughter Lydia’s respiratory health if I continue to rely on the (insert) supplements to return her to normal breathing capacity?”*

\* In addition, there are occasions when the client may wish to gain deeper perception and foreknowledge of the results of a previously established project or personal relationship – wherein the consequential results of that project or the new relationship have yet to materialize. By posing an “outcome question,” the Oracle of Tarot can provide the client with further guidance as to the emerging, behind-the-scenes, state of affairs stemming from such prior undertakings (*that are still in the works*).

In relation to creating the best possible “outcome question” for any Tarot reading (utilizing the 7-card Celtic spread), it is essential that the questioner recognize that there may well be one or more alternative measure(s) by which his/her *righteous* goal(s) may best be achieved. Perceiving and choosing such an “action step” and incorporating it into the question can be the key to obtaining the positive result the questioner is aiming for.

Put more succinctly, relative to the simplicity of the above example questions, a favorable, auspicious, outcome to the question may be assured upon employment of an alternatively chosen (fallback) course of action reflected within a more thoroughly detailed question—thereby prompting the Tarot’s fruitful disclosure and divulging of the route to success. Such a revised, in-depth, question can instill an effective means of revealing further detailed considerations of the matter – that can enhance one’s ability to garner the desired outcome.

In referencing the above example questions, instances of amended and more elaborate “outcome questions” may be fashioned and applied as follows:

- a) *“What will be the outcome if I seek to apply for a position with (insert name) corporation by first speaking directly with an upper management staff member in order to win the job?” or;*
- b) *“What will be the outcome if I travel on my own, by myself, to explore the Denver region’s universities?” or;*
- c) *“Together with reliance upon the supplements that Lydia now ingests, what will be the outcome for her respiratory health if I arrange for and implement the (insert) procedure suggested by Doctor Johnson?”*

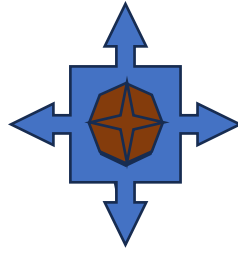
These examples are illustrations of the truth of the old adage; *“Your answer is only as good as your question.”*

It is of major importance for the client to note that oracular Tarot card readings derived from such “outcome questions” are only as instructive and helpful as the questions are comprehensive and precise.

Also, it must be reiterated that it is best to commit the question to writing or voice recording prior to commencement of the reading. Likewise, with the Reader’s assistance, it can be very instructive (in the long-term) to conclude the reading by recording the number and/or title of each card and its numbered position within both the seven (7) and nine (9) card spreads that were utilized. In this regard, the Reader shall readily assist the client with said take-away documentation for further pondering and contemplation. Cell phone pictures of both spreads of cards are often taken – to adequately record the reading. The client is also encouraged to make a voice recording of the entire one (1) hour session.

# The Nine (9) Card Celtic Tarot Spread

(Guide and Card Layout for Assessing One's Overall General Circumstantial Situation)



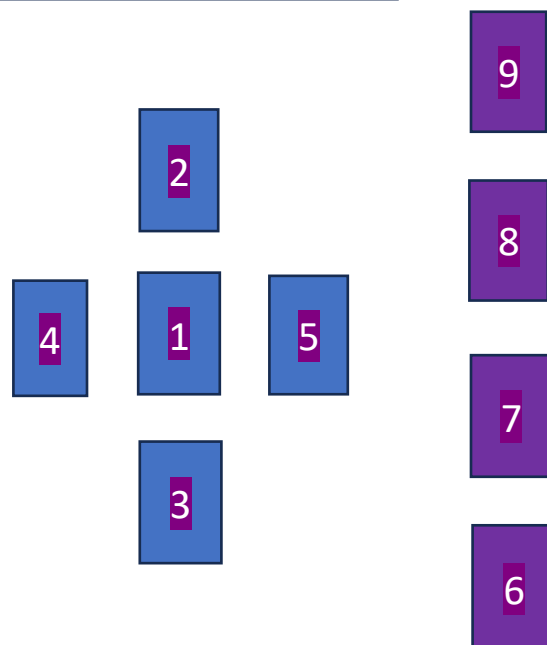
To enable interpretive correlation of this spread's nine (9) images to the client's circumstances, the Celts had assigned a specific meaning to each of the nine positions unto which each card is placed. After shuffling your situation into the cards and cutting the deck, begin the process of this reading by placing each card (face down) in the order of its numbered position, according to the diagrammatic pattern indicated below. Within the layout of this 9-Card "Positional Spread," the meaning of each card's placement is as follows:

- 1) A picture of the present
- 2) The highest that can be attained at this juncture
- 3) The hidden or unconscious factor(s) involved in present developments
- 4) The past (the element of the previous phase that has most influenced events unto the present)
- 5) The general future circumstantial condition

## Future Phase Projections

...These four (4) cards are depictions of evolving events that shall commence at a time close to the present, leading off into the future. These images represent situational affairs that are to emerge over the coming period of days, weeks or months, depending upon the frequency of intervals [phases] between Tarot consultations.
