person or organization for resale (e.g., pet store), animal rescues, animal shelters, trade, or give away Dog, or to use it in any experiment, laboratory or otherwise, or as breeding stock for a 'puppy mill.'

The dog shall reside with the buyer.

If Buyer cannot keep the dog, the dog has to be returned to the Breeder only, where the Breeder can find it a new home.

### C. HEALTH AND HEALTH GUARANTEE

Breeder certifies that Dog is of sound health and is free of all life threatening genetic diseases at time of purchase.

If within three days of this date, Dog should become ill, Dog may be returned to Breeder for a full refund.

Any veterinary or other costs incurred by Buyer shall be at Buyer's expense, unless prior Breeder consent has been given in writing. Buyer should contact Breeder immediately with any health concerns.

Failure by Buyer to comply with the terms and conditions of this Agreement and/or the separately signed Spay/Neuter Agreement (referred to in Section C) will render any health guarantee null and void.

Use of the following flea and tick preventatives, Comfortis, Trifexis, Simparica, Bravecto, Nexgard or injections will **void** all warranties. Topical treatment or flea & tick collars are recommended. Oral flea treatment pills are known to sometimes cause vomiting, seizures, and other serious ailments.

## D. OWNERSHIP RESPONSIBILITIES

It is Breeder's desire and stated intent that Dog is well cared for and placed within a proper environment for its entire lifespan.

Buyer agrees to:

- -maintain Dog within a humane environment and will properly train and care for Dog, providing Dog with adequate fresh water, food, affection, medical care upon sickness, disease, or injury, and other necessities during Dog's entire lifespan. Maintenance should include an annual health exam and routine vaccinations as recommended by a board-certified veterinarian.
- -act in good faith and not allow Dog to roam unsupervised and will assure that Dog be socialized and appropriately obedience-trained
- -have Dog properly licensed and inoculated against rabies, distemper, parvovirus, and other communicable diseases, as recommended by a qualified veterinarian.
- -Buyer agrees not to have the dog be kept chained or constantly outdoors. The dog has to be an indoor pet only.
- -Buyer agrees that they have to have a physical or electric fence if you want to let out the dog out without a leash.
  - -Buyer agrees to spay or neuter the dog ASAP as of adoption date \_\_\_\_\_\_
  - -Buyer agrees the dog is purchased as a pet and will not breed dog intentionally or by accident. If either happens, buyer will pay going rate for breeding dog. Current rate is \$20,000.
  - -the Buyer agrees that it is the Buyer's responsibility to accept the dog as described.

# E. RIGHT OF RECOVERY/REPLACEMENT

If, for any reason, Buyer cannot, nor does not opt to, maintain custody of Dog (at anytime during Dog's lifetime) Buyer agrees to immediately contact Breeder.

It is further agreed that:

- Dog is not to be sold by Buyer nor placed into a shelter, rescue or anywhere else, other than as a pet living with Buyer, without written consent from Breeder.
  - Breeder will assist in any subsequent placements of Dog and/or will accept return of Dog, each option at

no cost to Breeder.

- If Buyer is convicted of, or consents to, charges of animal neglect/cruelty/abuse during Dog's lifespan, Dog shall be immediately returned to Breeder and at no cost to Breeder.
- -In the event Dog is returned, the Buyer agrees to sign the necessary papers to return the Breeder as the sole owner of Dog.

#### F. TERMINATION BY DEATH

In the event Dog dies from natural, accidental or other causes other than those caused by Buyer's gross negligence or abuse, this Agreement shall terminate upon that date and neither party shall have any further obligation to the other.

In the event Buyer predeceases Dog, ownership of Dog transfers to Breeder.

# G. INDEMNITY

Buyer agrees to indemnify and hold Breeder harmless from and against all claims, liabilities, losses, costs, damages and expenses (including costs and attorney's fees) incurred as a result of damage to property or injury or death to persons allegedly caused by Dog while in possession of Buyer or heirs of Buyer.

### H. GOVERNING LAW AND ENTIRETY OF AGREEMENT

This Agreement between Breeder and Buyer (Parties) is non-transferable to a second party and contains the complete and total understanding of the Parties with respect to this Purchase and there are no other terms or agreements not included herein, except for a separately executed Attachment to Purchase Agreement. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.
