EFT FAQ'S

Will this information be kept secure? *Yes, your authorization form will be kept in a locked cabinet in the preschool office.*

Who will have access to the information? *Office staff will be processing the information and entering it into the online banking service. Once it is entered, the information is password protected.*

If I withdraw from the preschool, will the draft stop? *If you withdraw your child you will need to provide written notification to us of your withdrawal 90 days in advance to allow the preschool and the Depository adequate time to stop the draft. The preschool withdrawal is on the 15th of every month.*

Who should I contact if I have a question? *Email the preschool at genesisdirector@gmail.com if you have any questions.*

What will the draft look like on my checking account? *It will be noted as a debit. It may say, ACH Debit Genesis UMC DBA or some abbreviation.*

What happens if there are insufficient funds on the draft date? *If funds are unavailable, The Bank will NOT attempt to draft again, and we will contact you. You must pay tuition with cash and a bank fee of \$40.00.*

Will there be an additional fee if the funds are not available on draft day? *You will need to check with your bank. They may charge you a fee for insufficient funds. If the bank is unable to collect tuition for the month, the preschool will assess a \$40.00 fee. In addition, cash for tuition will be required.*

If I have two children enrolled, do I need to fill out two draft authorizations? *No, one will be fine.*

How do I find my routing number? *Your routing number is the nine-digit number found at the far left of your check (on the bottom).*
