## TRANSFER OF DECLARANT RIGHTS SHERMAN LAKES SECTION ONE AND TWO

WHEREAS, the proceedings necessary to transfer Declarant rights to the Association as required by the Declaration have in all respects been complied with.

**NOW THEREFORE**, the Declarant hereby memorializes its transfer of Declarant Rights, in accordance with the Declaration of Covenants, Easements, Restrictions and Assessment Lien Sherman Lakes Section One and Two as follows:

## TRANSFER OF DECLARANT RIGHTS
