## Puppy Deposit & Sales Agreement

### PURCHASE PRICE

Part of the purchase price will be paid immediately with this agreement as a deposit to guarantee the seller will hold the puppy for delivery/pick up for the buyer on the specified delivery/pick up date.

**FULL REGISTRATION:**

**LIMITED REGISTRATION:**

The purchase price does **NOT** include any delivery charges and/or extended stay charges which are calculated separately.

**A DEPOSIT in the amount of \$200.00 is required to hold this puppy for the buyer** until the delivery/pick up date. **Payment of deposit acknowledges this contract and is binding.** There are no refunds on deposits. This deposit signifies the intent on the part of the buyer to follow through with the purchase of this puppy. The seller reserves the right to void this transaction and refund the deposit if we learn of any reason why the buyer might not be suitable for the puppy. If the transaction is voided or if through some tragic accident the puppy were to die or otherwise be seriously injured before it goes to its new home then the deposit will be returned to the buyer; unless the buyer wishes to apply the deposit to another puppy, if one is available, or to a puppy from the next available litter.

**DEPOSIT PAYMENT METHODS - PAYPAL, CASH, CREDIT/DEBIT CARD, or WAL-MART TO WAL-MART MONEY TRANSFER.**

**PICK UP DATE**

This puppy will be available for the buyer to pick up personally at **Copper Creek Bloodhounds** on\_\_\_\_\_.

This date is based on our estimation of when the puppy will be naturally weaned and ready to leave its mom. Our puppies stay with their mom at an absolute minimum of 8 weeks of age. If the buyer is not able to pick up the puppy on the stated pick up date, we will gladly continue caring for the puppy for 3 days. However, we will add a charge of \$10.00 per day for boarding for every day after the scheduled pick up date and buyer is responsible for booster vaccines. If the puppy is not picked up by the end of day 3 and no arrangements have been made and agreed upon, then the buyer forfeits their deposit and/or any amount paid.

## **DELIVERY CHARGE**

The seller is more than happy to personally deliver your puppy to it's new home or to meet the buyer at an agreed in-between location. We charge \$1.00 per mile one way delivery fee. Our charge for delivering this puppy to \_\_\_\_\_ would be \$\_\_\_\_\_.

**The balance due at the time of delivery/pick up is \$\_\_\_\_\_ and is to be paid in cash only.** The balance due includes delivery fee, if applicable, and is credited the deposit amount.

**Shipping via air is available** at an average rate of \$450.00. It is the buyers responsibility to make proper arrangements to pick up the puppy at the agreed destination airport. \*Weather is a factor when flying a puppy due to airline regulations. **All out of state buyers that choose this shipping option are required to pay for the puppy and flight in full via Paypal friend to friend. When doing so, do NOT mark the option for paying for goods or services. This is due to the high number of people purchasing a puppy through Paypal then requesting a refund from Paypal after receiving the puppy. The total balance for the Puppy & Shipping must be paid in full, No later than, when puppy is 6 weeks of age to allow booking, scheduling and preparation for flight.**

## **HEALTH GUARANTEE**

**Copper Creek Bloodhounds** guarantees your puppy to be free from infectious diseases at the time the puppy leaves our premises. We do not guarantee temperament. We bred only from dogs that have demonstrated great stability. We provide a secure and loving environment for our puppies from birth and provide daily proper socialization. After delivery / pick up the responsibility is on the buyer to provide a good environment with proper socialization. It is the buyers responsibility to keep the puppy free from harm and bad interactions with other people, dogs and animals. Any negative exposure of the puppy to a bad experience with other people, dogs or animals can cause lasting effects. **The buyer agrees to provide a safe environment for the puppy and to keep the puppy healthy, maintain and stay current with all puppy vaccinations and provide periodic vet checks including an initial examination within the first 72 hours after delivery / pick up at the expense of the buyer.** The seller will provide the buyer with a puppy that leaves Copper Creek Bloodhounds clean, in good general health and that has no physical defects. De-wormings and first immunizations will have been completed and detailed in writing. Buyer agrees that he/she will take their puppy to their veterinarian within 3 days of receiving the puppy for examination and to schedule ongoing immunizations as recommended. If the buyers veterinarian finds the puppy to be in poor health, the Veterinarians' written description of the problem/problems must be provided to the seller within 24 hours of the findings and dated within 3 days of the date the buyer received there puppy. In such case the buyer will be refunded the price of the puppy or given a replacement puppy if one is available, once the puppy is returned to Copper Creek Bloodhounds at the buyers expense. Transportation costs, if any, will not be refunded and are not included in this guarantee. Expenses of treatment, exams, and test are the financial responsibility of the buyer. Failure to have the puppy examined by a veterinarian within 3 days of the date the puppy is delivered / picked up will void this health guarantee.

**RIGHT OF RECOVERY**

Should the buyer find themselves unexpectedly in a circumstance where they are unable to properly care for the puppy, the buyer agrees that the seller will be contacted first and given the option to either buy the puppy back and/or find the puppy a new home. Buyer agrees that the puppy will **NOT** under any circumstances be placed in a dog pound, rescue center, or pet store. This provision is to ensure that the puppy will **NOT** end up homeless or destroyed.

**GENERAL**

This written Agreement contains all the terms of this puppy deposit and sales agreement. No refunds will be given, all deposits are non-refundable and all sales are final. To ensure that the buyer can immediately reserve the puppy of their choice, The buyer and seller agree that this agreement is in full force by virtue of completing this agreement between the seller and the buyer. All disputes are subject to resolution in the sellers domicile: McIntosh County, Oklahoma.
