# forgiveness

Forgiveness may seem simple until we need to forgive following the death of someone dearly departed. A sea of unfamiliar emotions can make forgiveness impossible for a very long time. Until we forgive, as long as we harbor anger and resentment toward another, that person has power over us, preventing us from moving forward. Anger, until it is transformed into forgiveness, can fester into bitterness that corrodes the vessel that contains it and disfigures all that it touches.

If we are to achieve healthy measures of healing, we must eventually deal with forgiveness. We may need to forgive ourselves for not being able to protect the beloved person or prevent their death. We may need to forgive our loved one because of the way he or she died. We may need to forgive doctors or counselors for failing to properly diagnose, cure or save our loved one. We need to forgive anyone—ourselves, our child, husband, wife, parent, sibling or any other person—who intentionally or unintentionally contributed to events that led to the death of our loved one.

We need to forgive those who fail to support us in our grief, those who make clueless or insensitive remarks, avoid mentioning our beloved's name or their death, or just stay away. Forgiveness does not come easily or quickly but there is no time frame for forgiving.

Forgiveness does not change what has happened but it lifts a burden from our heart. It has been said that forgiveness is a gift we give ourselves. Forgiving frees us to heal, to love without fear, to live without bitterness and to know true peace in the future.

# Surmounting Holiday Grief

It's mid-January and bank tellers, store clerks, friends and family living far away are still asking the dreaded question: "How were your holidays?"

You don't really want to know. And I don't really want to tell you.

At first I automatically answered, "Good" but it gradually declined to "Fine" to "OK" to "Eh."

I discovered there were others around me who offered a "humph," groan, or heavy sigh when the question came up. I was not alone. We were not alone.

So I've decided to come clean for the rest of you. For those who didn't take down their tree Christmas Day afternoon, weary of the pretense and resolved to pack up the merry holiday and put it away until next year.

I don't want to ruin it for others, really. In fact, I hope to celebrate with you next year with a renewed merry spirit — or, maybe, some year. But I consider it a public service for those who struggled during the holiday season to share with the rest of you what it is like and to offer some suggestions to help us all better manage the lack of merriment. And to remind us that it isn't just Christmas or Hanukkah that cast a sad shadow on a portion of the population.

I don't know if it will ever truly be a very Merry Christmas for a family missing a member. Decorating the house and tree may become a chore rather than an annual pleasure. The cherished family of birch tree snow people is over-populated for the family of four who is now a family of three.

"We went from a family of six to a family of four," said a young person to me who lost a sibling and has another who is estranged. I nodded knowingly. Yes, the holidays are hard because they are measured by the missing.

A stocking hung by the chimney with care remains empty Christmas morning, except for a few notes placed in it as tribute. There's a space in the family pictures that will never be filled, even as the family may grow and expand over the decades. There's an empty place at the table no matter how many guests gather.

But death isn't the only Grinch that spoils holidays. Comedian and actress Amy Poehler writes about her divorce in her half-life memoir "Yes Please." She read numerous books about dealing with divorce and joked that she wanted to submit some suggested titles to her editor, such as "I Want a Divorce! See You Tomorrow!" (for co-parents). The final one was "The Holidays Are Ruined" with this summary: "This book is one page long and just contains that one sentence."

People often feel chagrined comparing grief from divorce to grief from death, but divorce is a death, of a kind, of the marriage and family that once was. Holidays hopefully aren't ruined forever but they are altered forever.

That's why Valentine's Day may be even worse for someone recently separated or divorced. I'm not a fan of this contrived holiday but maybe this year I'll throw a party for my friends who consciously uncoupled this past year.

I imagine St. Patrick's Day will be particularly difficult for friends who lost an adult son last year, one half of an "Irish Twins" set who is sorely missed. I imagine many of his friends and loved ones will raise a green-dyed pint in his honor, remembering very fondly a funny and spirited young man.

Veterans Day, Memorial Day, Fourth of July — those are holidays packed with picnics or parades. Yet families who lost a warrior or a veteran are remembering their personal patriot.

Flip to almost any month in the calendar and there's a family or friend mourning in the midst of the celebration — not even including birthdays, anniversaries, or the day of death.

Many organizations or websites offer suggestions on how to deal with grief during the holidays but I found the most complete, practical list at aarp.org. I've paraphrased it here:

- 1. Only do what feels right. You are very vulnerable right now, so all you need to do is get through the day, week, or season in a healthy way. You decide which activities, traditions or events you can handle.
- 2. Accept your feelings. You may feel peaceful one moment and gut-wrenchingly sad the next. Try to stay in tune with your own highest truth.
- 3. Call on your family and friends. Be honest about how you'd like to do things this year.

- 4. Focus on the kids. Many holidays place special attention on children and it often helps to focus on their needs.
- 5. Plan ahead. Create comforting activities in the weeks approaching a holiday so that you have something to look forward to rather than dread.
- 6. Scale back. You might opt for minimal decorations at home, not send holiday greetings, or limit holiday parties to small gatherings with your closest friends and family. Do whatever feels safe and comfortable to you.
- 7. Give. It's amazing how in times of grief, sometimes the biggest comfort is to give to others.
- 8. Acknowledge those who have passed on. Some ideas: lighting candles for them, talking about them, donating toys or books in their name, planting a tree, writing a letter, or placing an item of theirs among holiday decorations.
- 9. Do something different. Acknowledge that the holiday will not be exactly the same ever again. Accepting this will help manage expectations.
- 10. Skip it. If you feel that it will be too much for you and you'd like to simply opt out of participation in a holiday, let family and friends know. Plan alternative comforting activities for yourself and let someone know what you will be doing. Make sure someone checks in with you on that day.

I would add not to have expectations of what it will be like next year, either. Don't expect it to be better or worse. Time may not heal this wound —holidays may make it tender and raw. Don't judge yourself or anyone else in that regard.

Nonetheless, I refuse to surrender the holidays to a season of sorrow forever. This season, and every season, I hope none of us are defined by death but by love and compassion. I hope we are defined by hope.
