

Yes, I have a lot of background at this location and the project sets at 86th Ave PS. Firstly:

I am not sure how familiar you are with the history of the Fanno PS, the Forcemain and the public that surrounds it, but it is extensive and complicated. In this specific location, due to the previous breadth of interactions and complexity of claims and coordination in this neighborhood, it is my strongest suggestion that we communicate through a PI group member for this topic. If it stays in our group. Secondly:

The Citizen notes that this is the: "Portland sewer line running beneath the Fanno Creek Trail at the north end of SW 82nd Ave 3 blocks north of Garden Home Rd."

I have included a screenshot below:



They additionally note that this will "due to" work being requested by the Portland Golf Club which is north of this location, shown in green. If this is the case, I think it would be a private permitting situation, and although I have not reviewed any requests related to this location, we *should* if they are doing work over the pipe. But that wouldn't come though our group.

I think this is a good example situation that the PDX Golf Club would be getting permits from another entity, but it is our utilities. I am not sure who at COP to tag to make sure they are aware of this and make sure COP is involved in the permitting review? Thirdly, about the Forcemain:


This forcemain is indeed newer as a whole, it was replaced in 2011 via project E09115. PortlandMaps: Fanno Basin Pressure Line Garden

Home Section (see sheet C02, C08, and R02 for the SW 82nd Ave location specifically)

However, in and around 2017 a construction project E10599 occurred where I was the CM for the first half of the project before coming to work for Maintenance Engineering. The scope of this work was to physically dig and expose each manway location on the forcemains that were installed in 2011 and replace it with a straight spool section. This was because some, or one, of the manways had begun to show stress related failures on the flange of the vertical manway access (see below). This work was completed in late 2018.



The as-builts for this E10599 job aren't in any of the databases, so I will be getting that fixed. Meanwhile, the conformed plan set I did in 2017 for the construction effort shows that the manway spool replacements were at the locations below, this would be east of the location indicated by the Citizen in their initial email.



So, thoughts? If you have no concerns still, then I will reach out to PI to craft a response. We can discuss at our update meeting tomorrow. Thank you,
