Reading of Minutes from the 2014 Lindsey Family Reunion First Business Meeting was conducted by Vanise B. Lindsey. No changes noted.

Reading of Minutes from the 2014 Lindsey Family Reunion Second Business Meeting was conducted by Diana Gibson. No changes noted.

#### **Treasurer's Report** – Gloria Nixon

Gloria gave a review of the Lindsey Annual Financial Report for 2014 - 2016, which was included as part of the agenda package, emphasizing how our President leads by example; i.e., Willie pays his dues and scholarship donations early. She reminded the family about dues payment: annual dues of \$25.00 due by January 31<sup>st</sup> of each year; or \$50.00 paid at each family reunion. Gloria also emphasized the importance of making scholarship donations with dues payments in support of the family's scholarship program.

Gloria then stated that she will be resigning as Treasurer in 2018, if not voted out this year. Mentioning it now will provide family members ample time to consider an interest in serving in this position by the 2018 family reunion.

Gloria then recommended an increase in the seed money that's provided to family reunion host committees. She recommended that the current amount be increased from \$1,000.00 to at least \$1,500.00. The reasons she cited for recommendation were: deposits required for reserving hotels and other venues have gone up over the years; as the cost of living increases each year, we should make similar adjustments with our finances; and family members 80 years of age and older are exempt from registration fees that adds a financial burden for host committees in their planning that was further elaborated on by the current host committee chairs, Barbara and Melvin Lindsey.

The Treasurer's report was accepted and referred to the Audit Committee chaired by Richard Lindsey for review, and the results to be presented at the second business meeting session.

President Willie Evans commented that procedures should be put in place to ensure family members 80 years and older are accurately captured in registration counts. He also commented that the requirement to provide host committees \$1,000.00 to help offset early expenditures to reserve desired services for family reunions was included in the family bylaws that were established and approved in July 2004 (i.e., twelve years ago). Due to the importance of this topic, further discussion will be added to the second business meeting agenda under New Business.

#### **Opening remarks from our President:**

President Willie Evans thanked everyone for attending the 1<sup>st</sup> business meeting of the 24<sup>th</sup> Lindsey Family Reunion. Due to time constraints, he proceeded with the agenda.

**Free Raffle:** Vice President Melvin Lindsey and his wife Barbara, the hosts of this reunion, decided to hold a raffle as an incentive for full family participation and involvement in the business meetings especially since over 100 people registered for this reunion. They contributed a bottle of Dom

Perignon for each meeting. Chaplain Robert Ware won the raffle and it was suggested that Communion be held immediately after the business meeting.

#### **Committee Reports**

#### Scholarship - Diane Gipson

Diane made mention of an error in the Financial Report regarding a scholarship award for a recipient who had previously received an award. Gloria apologized stating it was a copy and paste error.

**Question** asked by Ken Gipson: How is the scholarship fund funded?

Answered by Diane and Gloria: During the business meeting at the reunions, the family is asked to separately submit funds apart from dues. They are deposited into the same account but there is a breakdown separating dues from scholarship donations. There are two types of scholarships, the Lindsey Family Academic Excellence Scholarship and the Lindsey Family Scholarship. The scholarship program allows for the award of four scholarships each year: one (1) for \$500.00 – Academic Excellence Scholarship and three (3) for \$300.00 – Lindsey Family Scholarship.

Question asked by Theresa Maxwell: Are there other ways we can submit funds?

**Answered** by Diane Gipson and Willie Evans: Besides making donations at the family reunion, you can mail your contributions directly to the Treasurer, Gloria Nixon. Also, Karamoko Andrews (family's webmaster) is working on the website to allow for dues and scholarship donations to be made online

#### Website & Newsletter - Willie Evans

Karamoko is working on changes to the website to allow for online payments, and the plan is to publish a newsletter in Fall 2016.

#### Family Directory & Family Tree – Edith Wright

Everyone was asked to review the information on the hard copies of the current family directory that was passed around, fill out a white index card with the corrected information for you and other family members as needed, and return the completed cards to Edith.

Edith made note of a form for each family to fill out that Carletta Montgomery made 6 years ago. The intent is to obtain accurate information that's needed to update our family tree. This is necessary

because as we multiply, so does the branches on our family tree.

#### Youth & Young Adult Involvement – Tia Overstreet

Tia is working with Barbara and Melvin to plan activities for the youth during the reunion. However, at the banquet on Saturday evening, there will be presentations by the youth on "The Importance of Family/Family Reunions."

#### Cemetery Report (William Franklin - Chairperson) - Willie Evans

Willie maintains ongoing contact with William Franklin on status of the cemetery grounds at Bellview Park AME Zion in Evergreen, AL. #### **Administrative Remarks** – Barbara and Melvin Lindsey

Melvin reiterated the incentive behind the free raffle – to encourage family participation and increase meeting attendance. Melvin and Barbara contributed the donations themselves. They discussed the pricing of catering services and the importance of registering early. There are a lot of out-of-pocket expenses until the registration fees arrive. Early registration helps offset these early expenses for the host family.

Regarding the family outing, the private picnic location is an estate with a private pool, spa, basketball court, pool table, TV, tables for card/domino games, and indoor/outdoor seating. Everything you need for a picnic with the benefit of air conditioning! There will be NO smoking on the premises, drink responsibly and bring towels. Colored arm bracelets were in the registration packets to identify those who paid for the family picnic. The arm bands are to be worn with the Lindsey Family Reunion T-shirts. The family picnic will be from 2:00 pm to 6:00 pm. Buses will begin loading at 1:45 pm and depart for the estate at 2:00 pm sharp!! In addition to the information requested on the front of the application, the applicant should describe in detail on a separate sheet of paper (do not just list) your level of involvement in extracurricular activities in your school and community and list any awards you might have received during the applicable school year. Include membership and office held in clubs, school and community organizations. (Note: your response to this paragraph weighs heavily in the award decision.)
