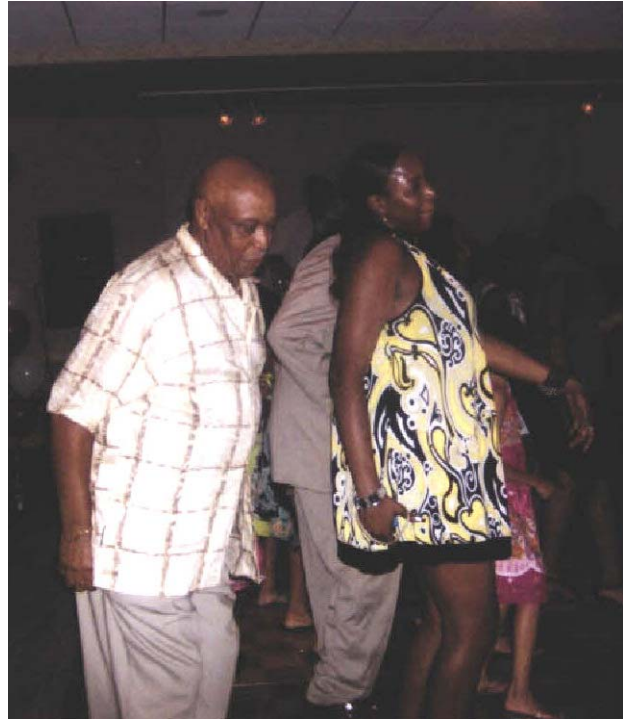












## THE OLDEST FAMILY MEMBER AT THE 2010 FAMILY REUNION

Rosa is the mother of 4 children, Jimetta (deceased), Ben (Leon), Roderick (deceased) and Sandra. She has 3 grandchildren, Jonathan Davis Walker Sr., Khalil-Mutope Habitullah Davis, and Khalida Jimetta Malak Davis. Rosa has one great grandchild, Jonathan Davis Walker Jr.

### In Her Own Words...

I was born in Evergreen, Alabama on January 19, 1920, the eldest of Henry and Phillis Lindsey's eleven children. At age 6, I began Lime Hill Elementary School, located on the site where my parents later built their final home. We lived on a small farm, with my father devoting part of his earnings to his sisters' education. My life centered on my education and caring for the children in the family. When I was 11, I spent a year with my mother's aunt, in Pensacola, because she wanted to support me through 7<sup>TH</sup> grade.

In 1933, age 13, I was elected Belleville Faulk AME Zion church's Sunday school convention delegate and the reporter for the "Star of Zion", the denomination's national newspaper. The other delegates' responses to my report caused the Presiding Elder to ask my father about my future school plans. There were none because I had completed 8<sup>TH</sup> grade and no high school was then accessible from our farm. Based upon my convention success, and the Presiding Elder's recommendation, the conventioners voted to award me a scholarship to Lomax Hannon ( Methodist boarding school), to complete my high school education. In 1937, at age 17, I graduated.

The Summer of 1937, I became a teacher. My Evergreen neighbors hired me for their Lime Hill summer school. When Lomax's Principal, Reverend Solomon Snowden Seay, spoke at my church, he praised my academic accomplishments, especially my mastery of French. Since Lomax had no French teacher for the coming year, Rev. Seay asked about my college plans. If my family could not afford college, he had decided to hire me as Lomax's first year French teacher, paying me out of his own salary. From September through November, I taught. Rev. Seay praised my performance. Unfortunately, due to the number of poor students admitted, Rev. Seay was never able to pay me.



As a result, I asked my Aunt Doll (Carrene Lindsey Mahorn) if I could move to her Jersey City home and seek work. I remained there until World War II threatened, working in a cigarette factory before entering domestic service. Metropolitan AMEZ church, where I ushered, was my church home. I deeply enjoyed that time spent with my first cousins and 2 generations of my Uncle Henry's children. And I take pride in discovering Oscar Micheaux's movies there!

I returned to Pensacola before World War II started, wanting to be where I could visit my parents. I lived with 2 of my sisters, Ella and Jennie, initially at a succession of older relatives' homes. I was the first of the 3 Lindsey sisters employed by the public library. We attended Allen Chapel AME church, where I sang in the choir.

In 1943, I married Jesse Leon Davis. (The minister was my Baptist cousin.) Between 1943 and 1950, I bore 4 children. My eldest, Jimetta, died in infancy. I take pride in the first Black Pensacola votes being cast while I lived there.

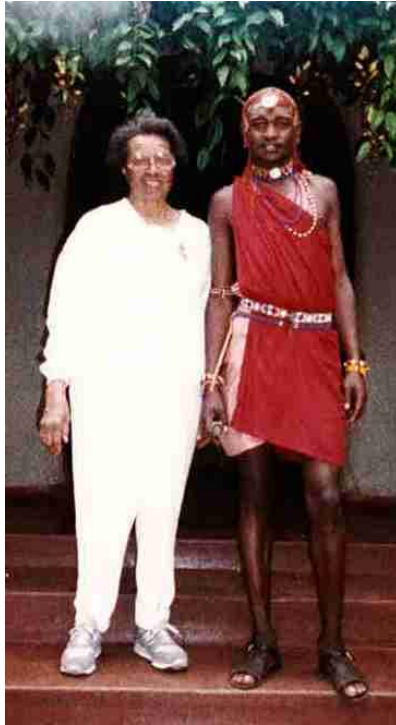
The year 1947 found my husband moving to Detroit in search of opportunities. The following year, my sons and I followed. In 1952, we purchased our home and I returned to work. From 1953 through 1963, I worked in food service, training under a major hotel's chef evenings to become a Detroit Public School cook. Working there allowed me to spend the majority of those years in the schools that served my sons and cousins' children. In 1962, Jesse and I separated, divorcing in 1969. By the time he died, we were friends.

In 1964, I started Licensed Practical Nursing School. Following graduation, my first job brought the joy of renewed relationships with 2 maternal cousins. One, Elfrieda Torrey (Maxine Stott's sister), worked with me and lived on the next street! My 2 youngest children, Roderick and Sandra, also entered the work world where I worked. In 1974, I began my life's dream, attending college! From 1974 through December 1979, I worked as a LPN full time while completing Wayne County Community College's Registered Nurse program! After graduation, I became a Rehabilitation Nurse, retiring only after a 1970 work site injury.

While still working as a RN, I was a founding member of my church's Health Ministry, becoming the nurse volunteer coordinator. We focused on blood pressure control and AIDS prevention. When the church created its first Vacation Bible School, I volunteered for nurse duty. I was also a founding member of the church's adult choir. I have attended the same church since 1957. I remain proud that my brother, James Leo Lindsey, and son Ben's (Leon) families attended the same church.



Church membership has also provided dreamed of travel opportunities. Lomax Hannon taught about Africa. In 1990, in time for my 70<sup>TH</sup> birthday, I went on a church four country Africa tour! My treasured memories include riding in a doorless, Zimbabwe military jet, touring the Great Wall of Zimbabwe, going on safari with the Masai and finding out, belatedly, that I attended a party hosted by my nephew, John Adams', former Lusaka (Zambia) neighbor! In 1988, we went to Hawaii. Visiting my niece, Carletta Montgomery's, family there was wonderful!



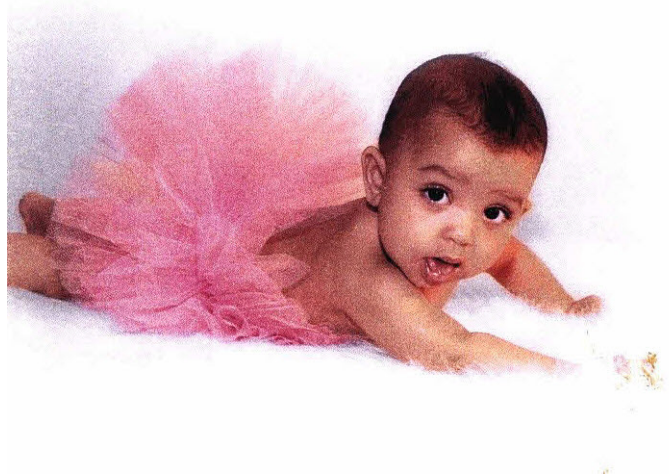
Of course, my most joyous accomplishments began about 40 years ago, when I became the Grandmother of Rod's son, Jonathan Davis Walker, Sr. Jon's birth brought the beloved gift "inheritance" of his older siblings, Eugene Jackson and Mary Walker. ## The Lindsey Family Origin

DNA testing to determine family lineage has emerged since the beginning of the millennium. There are now scientific databases containing samples of DNA from all areas of the world. DNA is found in every cell of our body, they are considered the building blocks for everything we are; it contains traits for hair color, eye color and height.

So the task was undertaken to determine the Lindsey lineage. As a family we have been able to trace back to the last slaves, Jonas & Rosa Lindsey, so we have decided to use the new available technology to go back even further and explore the Lindsey blood line at its origin.

Just a quick overview of the process and we will present the results. To explore the Lindsey lineage we utilized the African-Ancestry.com company for tracing Mitochondrial-DNA, others who have used this service that you may be familiar with are, India Irie, Dr. Gates of Harvard Univ, Spike Lee, Andrew Young, Donnie Simpson, Actors, Entertainers, Athletes, the list goes on.



We selected the Patri-Clan test so a Grandson of Henry Lindsey was needed for the sample. Cousin Benjamin Lindsey of Brooklyn, NY was tested. The PatriClan Test traces paternal ancestry by analyzing the Y-chromosome men inherit exclusively from their fathers. So Benjamin's results would be the DNA of his father Henry Jr., the same as Henry Sr., and so on. So the results would be the applicable to all the children, grandchildren, and great grand children and so forth of Jonas Lindsey.

So, the sample was taken, sent off and returned with a 100% match of identical genetic markers to the Balanta People of Guinea-Bissau. Balanta literally translates to "Those who resist".



The Republic of Guinea-Bissau in which our ancestors are from is located on the western coast of Africa it is bordered by Senegal to the north. It's about the size of the state of Maryland. It became the colony of Portuguese Guinea in the 19th century. Guinea-Bissau obtained its independence in 1973 and was officially recognized in 1974. It is presently a relatively poor country marked by political unrest. The Balanta however have remained outside the colonial and postcolonial state because of their social organization.



The Balanta are located mostly in the southern coastal region part of the country, representing more than one-quarter of the population in Guinea-Bissau. Significantly, Balanta do not typically refer to themselves as 'Balanta' but as B'urassa, or Urassa in the singular. This is our heritage everyone.

Now we just want to provide you with some brief history and information that we have been able to obtain through research of the Balanta.

Early Balanta society was decentralized where elders ruled (no monarchy, no royalty but system of extended family with matriarchs and patriarchs). Male elders held power, but regionally and in the broader Balanta society this power was not concentrated in a single household or ruling class.



The earliest European observers indicated that Balanta governed themselves through institutions controlled at a very local level. That is, they made clear that these coastal farmers were not organized in states. At the beginning of the sixteenth century, Fernandes a European settler said that he observed no ruling class, individual or governing body in Balanta society. Everyone worked in the fields, no families managing to exclude themselves from daily labor.

In the nineteenth century, European observers said that Balanta territories were the most densely populated in Guinea-Bissau yet these territories fell victim to the 'slaving frontier' facilitated by one of West Africa's most powerful states, Kaabu who closely assisted in the slave trade with European countries.

At the end of the sixteenth and start of the seventeenth century, the patterns of life in coastal Guinea-Bissau changed dramatically as violence associated with an expanding Atlantic slave trade proliferated. As Kaabu (African state) produced and traded captives over the course of the century that followed, Balanta retreated to isolated and riverine areas near mangrove swamps in Guinea Bissau. There they established defensive villages to defend against slave raiding. As a result of the relocation to defend against the slave trade the Balanta began a long process of refashioning their social structures and agricultural practices to meet the challenges of a new era.

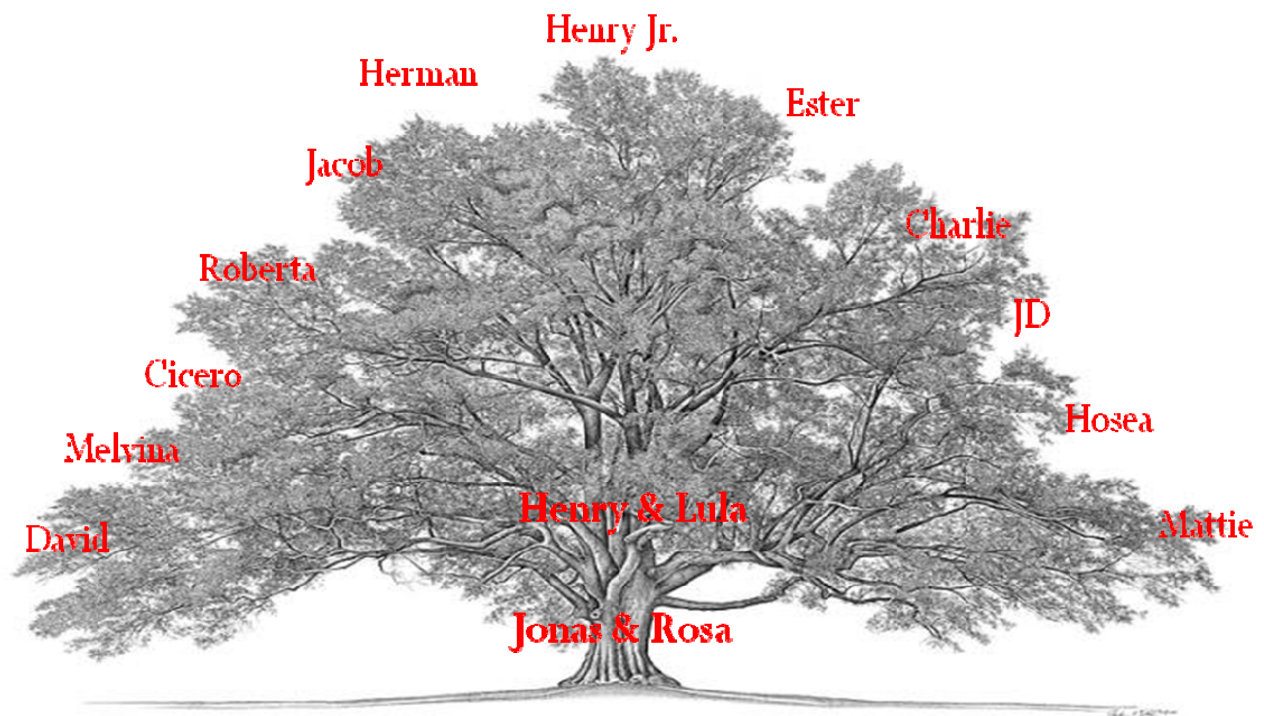
Oral tradition amongst the Balanta has it that they migrated westward from the area that is now Egypt, Sudan and Ethiopia to escape drought and wars. Today, the Balanta are mostly found in the south and central regions of Guinea-Bissau and are also thought to be part of the old, vast Mali Empire. Language Spoken: Balanta



As for religion the Balanta are largely a spiritual people. As for the country of Guinea Bissau Catholicism has been partially accepted, Islam is strong and practiced along with spirit worship. That's just



some basic information, there is so much more to learn about the Balanta and Guinea Bissau, what you've heard will be posted on our website and expanded upon. But this is just a portion of our lineage; because of course we are made of so many elements. But we, the descendants of Jonas Lindsey are of the Balanta people of Guinea Bissau.

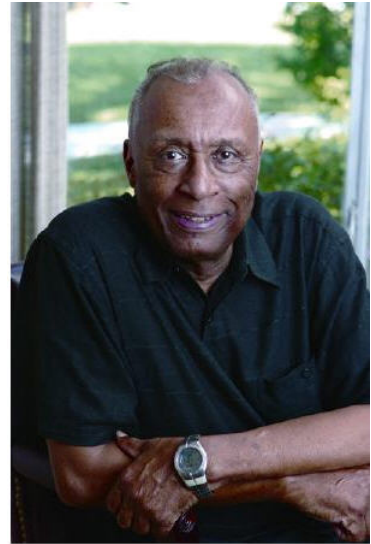
## Black History Corner

Did you know that Henry Sampson was the patent holder for patent # 3591860, THE GAMMA-ELECTRICAL CELL (Cell Phone)?

## **LINDSEY FAMILY OFFICERS AND COMMITTEES**

The following is the list of Lindsey Family officer and committee positions, the names of the family members occupying the various positions and a short description of the duties and responsibilities of each position:

### **Finance Report – Melvin Lindsey, Vice President**

On behalf of our Treasurer Gloria Nixon, in her absence, Melvin Lindsey provided the financial report. Gloria extended her thanks to the family members who paid their dues (\$25.00 per year; \$50.00 bi-

annually). \$835 was collected during the 2008 Business Meeting. It is important that everyone pays their dues. The money is used for bereavement, newsletter (postage, paper, envelopes, and ink), seed money for the host family and scholarships. Barbara Lindsey will collect for this year. She will be available throughout the reunion (meetings, banquet, etc.). Barbara will record the information and forward it to Gloria. Gloria also wanted noted that she received \$200 from Corinet Lindsey in July 2010 and it will be reflected in the next report. The current report is through June 2010. **Discussion:**

Yvonne Ware suggested that senior citizens as of a certain age (i.e. 80 years old and over) do not have to pay the family reunion fee and as of a certain age (i.e. 65-79 years old) pay half price.

President Willie Evans stated that this recommendation would be for the purpose of honoring our senior family members and provide them with complimentary entrance in to all family reunion activities.

There was a lengthy discussion. We heard from previous reunion hosts (Anne Lindsey, Raynell Lindsey, and Michael Lindsey) as well as other family members including those 80 years old and older. Some of the comments/suggestions/clarifications were:

- \* Feel free to donate whatever you can.
- \* This would be to show our appreciation and not to be perceived negatively. It is an honor.
- \* Consider fundraising.
- \* Family reunion fee varies based on location and activity planned.
- \* Different color registration forms could be used for seniors.
- \* Funds will come from the treasury. It is imperative that everyone pays their dues so that we can honor our commitment if this is voted in.....Remember that the money will need to be paid...the activities are not free.
- \* We need to look at cost. Some family members with large families are not able to participate. The reunion should be accessible to everyone.

- \* Consider providing family reunion registration fees to family members as a gift (i.e. Christmas, birthdays, etc.).
- \* Start saving early – we have two years.
- \* Be responsible – Pay your family reunion dues.
- \* After fees are established, have a committee outside of the host family take a look at affordability for families that may be challenged (i.e. large families) - Diane Gipson and Vanise Lindsey volunteered.
- \* Make a commitment to attend the family reunion early; adhere to the deadlines. Even if you do not have the money at that time and know that you will be attending, let the host know of your intentions. It helps with the planning.
- \* Plan ahead. Make deposits.

#### **Vote/Decision:**

Carletta Montgomery made a motion that all family members 80 years old and over will have free registration for all future family reunions. Michael Lindsey seconded the motion. All were in favor and the motion was passed.

Note: This decision does not impact the family reunion dues.

#### **2008 Family Reunion Report – Anne Lindsey**

The total attendance was 87 (75 attended all activity). The feedback regarding the 2008 Family Reunion was very positive. Everyone said that they had a great time. Anne stated that receiving feedback is important. It is important to hear what went well and what did not. This helps in the planning of future reunions. Anne also talked about the importance of timely communication. It is helpful to hear family members' intentions early. Let the host know that you are planning to attend even if you will be submitting your money at a later date.

#### **Family Directory – Carletta Montgomery**

Carletta passed out forms for everyone to complete. She plans to have an updated family directory in 3 months. She apologized to those who did not receive the newsletters. She passed out copies during the weekend. The family tree will be at the banquet. Information that she collected will be added and on display in 2012.

#### **Scholarship - Diane Gipson**

For 2010, she received one application. A scholarship will be awarded to Terry White of Melrose Park, IL. He will attend St. Ambrose University in Davenport, IA. His parents are Erika Lindsey (deceased) and Terry White.

Each year, the Lindsey Family Scholarship Committee will award two types of scholarships to graduating high school seniors who continue their education:

1. Lindsey Family Academic Excellent Scholarship – One scholarship will be awarded in the amount of \$500 to the applicant with the highest academic grade point average.
2. Lindsey Family Scholarship – The dollar amount of this scholarship is \$300 and one to three scholarships will be awarded in this category.

The deadline date for each year's submission of scholarship applications to the Scholarship Chairperson

Include membership and office held in clubs, school and community organizations. (Note: your response to this paragraph weighs heavily in the award decision.)

**D. Evaluation Criteria:**

- \* Grade point average (official copy of student's grades must be provided).
- \* Level of involvement in Church, School and Community Activities based on the information provided as required in paragraph b, above.
