

LINDSEY FAMILY OFFICERS AND COMMITTEES

The following is the list of Lindsey Family officer and committee positions, the names of the family members occupying the various positions and a short description of the duties and responsibilities of each position:

President: Willie E. Evans

The President shall serve as the Chief Executive Officer of the organization and shall be an ex-officio member of all committees with the exception of the elections committee. The President shall convene and preside over all business meetings of The Lindsey Family Reunion and the Executive Board. The President shall be responsible for the implementation of actions approved by the membership, appoint the chairperson(s) for all committees, fill by appointment all vacated offices, and perform all other duties pertaining to the Office of President. Only a Lindsey descendent can hold the position of President.

<u>Vice President:</u> Melvin Lindsey

The Vice President shall assist the President in the performance of his/her duties and perform all duties and functions of the President in the absence of the President or upon resignation by the President. The Vice President shall coordinate the activities of all committees and perform other duties as assigned by the President.

Recording Secretary: Diana Gibson

The Recording Secretary shall maintain a record of the proceedings of the organization, shall produce records upon request of any family member, and shall read the minutes of the previous meeting at each Executive Board and Family Reunion business meeting.

Assistant Recording Secretary: Vanise Lindsey

The Assistant Recording Secretary shall perform the duties and functions of the Recording Secretary during the absence of the Recording Secretary at any Executive Board or Family Reunion business meeting or upon the resignation or incapacitation of the Recording Secretary.

Treasurer: Gloria Nixon

The Treasurer shall be the chief financial officer of the organization. The Treasurer shall have custody of all organizational funds and securities; shall keep a full and accurate account of all receipts and disbursements in books belonging to the organization; shall deposit all monies and other valuable effects in the name of and to the credit of the organization in such depositories as may be designated by the Executive Board; shall provide a written report of all recent financial transactions at each Family Union or whenever called upon.

Financial Secretary: Janice Jackson

The Financial Secretary shall maintain a record of all dues paying members and submit notification of renewals when due; shall provide for collection of dues; and shall report on the status of paid up family members. In the absence or disability of the Treasurer, the Financial Secretary shall perform all the duties of the Treasurer.

Assistant Financial Secretary: Leon Davis

The Assistant Financial Secretary shall perform the duties and functions of the Financial Secretary in the absence or incapacitation of the Financial Secretary.

Chaplain: Robert Ware

The Chaplain shall serve as the spiritual and inspirational leader of the organization and shall perform divine and nonsectarian services at all meetings and shall conduct such ceremonies as may be required, such as giving the invocation and benediction at organizational meetings, events and functions as requested by the President. The Chaplain shall serve as a member of the Memorial and Amenities Committee.

Parliamentarian: James Lindsey

It shall be the duty of the Parliamentarian to assist the Presiding Officer in the interpretation of the Bylaws and provide parliamentary upon request. The Parliamentarian shall serve as a member of the Bylaws Committee and is responsible for keeping peace and good order in all meetings of the organization.

Historian: Catherine Williams

The Historian Shall compile and maintains a chronological history of the activities, events and functions of the organization.

<u>Scholarship Committee:</u> Diane Gipson (Chairperson), Elaine Crosby, Michael Lindsey, Lilly Fleming

The Scholarship Committee shall be responsible for the implementation of the organizations scholarship program award scholarships to deserving family members that are graduating high school seniors or graduate students. The principal functions of this committee shall be: develop the scholarship selection criteria; develop and manage the distribution, collection and evaluation of scholarship applications; determine the annual awardees; and present the awards approved by the Executive Board to the recipients.

The Family Directory Committee shall be responsible for maintaining a current family directory containing the names, addresses, email addresses, telephone numbers and other pertinent information of all members of The Lindsey Family Reunion. The family directory shall be distributed to all family members and made available upon request by the President.

Bylaws Committee: Frank Lindsey (Chairperson), Diane Gipson, Shavon Bonney

The Bylaws Committee shall be responsible for establishing the set of rules that govern the internal affairs of the organization. The Bylaws Committee shall insure that the Bylaws are appropriately updated to conform to approved amendments.

<u>Audit Committee:</u> Richard Lindsey (Chairperson), Catherine Williams

The Audit Committee shall be responsible for conducting a biannual audit of the organization's financial records; determining the appropriate procedures for the audit of the books and records of the organization; and presenting an audit report and any accompanying recommendations to the Executive Board at the next scheduled Family Reunion.

The Lindsey Family Newsletter Committee shall be responsible for the development of a newsletter to disseminate information of relative importance to family members.

The Family Tree Committee shall be responsible for updating the Lindsey Family Tree insuring that it accurately reflects the family's complete lineage.

Youth and Young Adult Involvement Committee: Janice Jackson (Chairperson), Dorothea Ryales, Nichole Pepper, Michael Lindsey, Rev. Streeter, Diane Gipson, Barbara Lindsey, Shavon Bonney, Clyde Crosby

The Youth and Young Adult Involvement Committee shall be responsible for recommending ways by which the family's youth below the age of 25 can be represented at the Family Reunions.

<u>Cemetery Committee:</u> Clevon Stotts (Chairperson), Frank Lindsey, Fred Lindsey, William Franklin

The Cemetery Committee shall be responsible for investigating and deriving at a final resolution of the Lindsey cemetery plot in Evergreen, Alabama.

<u>Memorial and Amenities Committee:</u> Dorothea Ryales (Chairperson), Edith Wright, Sakinaha Rasseheed, Lillie Fleming, Frankie Brown

The Memorial and Amenities Committee shall be responsible for sending appropriate corre-


spondence (i.e., card or flowers) on behalf of the Lindsey Family in cases of sickness, injury and/or death of a Lindsey family member. The Assistant Recording Secretary and the Chaplain shall serve as members of the Memorial and Amenities Committee. All matters concerning the health and welfare of the membership will be referred to the Memorial and Amenities Committee. The Memorial and Amenities Committee shall give a report of its activities to the Executive Board and at each Family Reunion.

The Fund Raising Committee shall be responsible for developing programs, activities and events to strengthen the organization's financial posture.

1st Business Meeting Minutes

Friday, 7/25/08

The first business meeting of the 20th Lindsey Family Reunion was called to order by President Willie Evans at 10:13 a.m. on Friday, July 25, 2008 at the Ramada Lakeshore Hotel.

The opening prayer was given by the family's chaplain, Robert Ware.

The President asked the meeting agenda be reviewed for adoption. The motion was made/ seconded and then the agenda was adopted.

The President provided opening remarks and spoke on the importance of holding and conducting business meetings at Family Reunions and emphasized the opportunity provided for the Lindsey family to get together, meet and greet each other at the reunions.

Minutes of the 19th Lindsey Family Reunion two business meetings were distributed and members were requested to review the minutes at their leisure due to time constraints.

<u>Treasurer's Report</u>: (Gloria Nixon, Chairperson) Gloria opened a 'select' savings account for \$10,000.00 leaving the remaining \$600.00 in a checking account. She was later informed by a bank representative that a 'select' account was for personal, not business accounts. \$5,000.00 will be moved to a CD account. Committee Reports:

- <u>Cemetery</u>: The Treasurer, Gloria Nixon, reported \$200.00 (\$100.00 annually) was submitted to help with
- upkeep of grave site.
- **Family Tree:** (Gloria Nixon, Chairperson) still needs more input. Requests for input information will be made during family outing. Accepting volunteers from family members to take a "branch of the tree." Carletta will formalize the specifics. (Family Coordinator/Tree Branch, 5 are needed). The 5 will get assistance for their tree branch.
- <u>Family Directory Website</u>: (Nicole Pepper, Chairperson) working on inputting family email addresses into Newsletter. It was noted a few years ago, Nicole Pepper established a Lindsey Family Website on Yahoo and Willie Evans established a Lindsey Family Yahoo Groups for communication purposes.

- <u>Family Newsletter</u>: Barbara Lindsey stepped down as Chair of the Family Newsletter Committee. Carletta Montgomery volunteered to take on this responsibility and Edith Wright volunteered to assist. The family newsletter is to be used as a means of family communication and plans are for a hardcopy to be posted to the website as a means of keeping everyone informed.
- **Scholarship:** Report from the Scholarship Committee was deferred until the second business meeting.

NEW BUSINESS

- 1. The President presented a case for the establishment of a new committee to assist Host Family Reunion Committees in the planning and execution of family reunions. The duties and responsibilities of this committee were passed out for the family's consideration and approval at the second business meeting.
- 1. **Nominations.** The President proposed the following nominations procedures that were voted on and adopted by the body.

- (a) A candidate should complete the blank ballot form identifying the position of interest and turn it in to the designated family member appointed to chair nominations and elections at the date and time specified.
- (b) Prior to holding elections at the second business meetings, the Nomination Committee Chair shall give a report of the offices that received a self-nomination ballot. Prior to holding elections, one last opportunity will be provided to take nominations from the floor.
- (c) At the conclusion of Nominations, elections will be taken by secret ballot. A candidate receiving the majority vote shall be declared the winner of said office. For all unopposed positions, a motion may be made for the Secretary to cast a single unanimous ballot for the election of the Nominees. No person shall hold more than one elected office during any given term.

Edith Wright was appointed by the President to Chair the Nominations Committee. All officer positions were open for nomination. The following positions to be voted on follows:

•Vice President •Chaplain

•Recording Secretary •Parliamentarian

•Assistant Recording Secretary •Historian

Administrative Remarks:

- (1) A family reunion cruise was mentioned and the idea was not well received. Two previous family reunion cruises were cited and negative comments were made regarding how expensive cruises, how it would limit those on fixed incomes such as the elderly, retirees, students and children.
- (2) It was also mentioned that family reunion host committees consider other time-frames other than the July 4th such as late June, middle to late July, or even early August.
