- Dispensary Has Chosen the Program: Silver, etc. and called Carolyn (918) 521-9349 to set up the Date, Time & Location of the Event.

- Bill's Bud Connection Has Given a Huge Discount on the Dr Recommendations and the Upload Assistance Fees for the Day of the Event.

(Reg Adult Dr Rec Fee \$60 – Day only of event \$30)

(Reg Adult Upload Assistance Fee \$40 – Day only of Event \$30)

(Reg Adult Dr Rec w/ Caregiver Fee \$60 – Day Only of Event \$30)

(Reg Adult Dr Rec w/ Caregiver Upload Assistance \$80 – Day only of Event \$60.00)

Minors are Required to have 2 Dr Recs

(Reg Minor (1) Dr Rec Fee \$60 – Day only of Event \$30 covered by the Dispensary – Parent to pay for the 2nd Dr Rec \$30.00)

(Reg Minor Upload Assistance Fee \$100 – Day Only of Event \$70)

- Please Note that Minors and Caregiver Uploads are more Extensive: The Caregivers are required to have their own OMMA account and are also required to have a signed Caregiver Attestation form signed by the Adult Patient UNLESS it is a Minor then the Adult Caregiver is required to sign the form.

- Bills Bud Connection Will Create a Flyer about the Event and email it to the Dispensary.

- Bills Bud Connection and the Dispensary will Share the Event to All Their Social Medias

- Dispensary Can send out a Promotion thru their Metric System to All Clients to advise them of the Patient Drive (This lets them know if they need to Renew their MMJ Card or know someone that needs to get their card – BBC will be there to assist them)

- The Dispensary Pays Bill's Bud Connection in Cash When Our Office Arrives at the Event for the Chosen Program.

- Please Note: If the Number of Clients you Thought would be at your Event and Do Not Show Up – The Dispensary Is Still Required to Pay the Fee that was Contracted Verbally or Done by A Written Contract.
