The organization is guided by a shared leadership structure between Cesar Martinez (CEO and Board Member) and Alberto Moreno (CFO, Director, and Program Architect). Alberto Moreno leads all nonprofit development, grant strategy, compliance systems, and operational management.

Alberto Moreno also serves as Founder of Apex Legacy Freedom and CEO of Apex Advisory Group. These entities provide the structural backbone and digital capacity that enable the nonprofit's daily execution and growth.

The facility at 20795 Main Street, Carson, CA is privately leased by Cesar Martinez and used for designated nonprofit programs. Use of the space is donated in-kind to support public youth services. Any private or for-profit activities occurring at this facility are separate from nonprofit operations.

Apex Advisory Group fully funds the nonprofit system infrastructure, including digital hosting, domain and email platforms, compliance software, and legal filings ensuring that nonprofits like Xander Sports are operationally sound and publicly accountable.

Today, those same systems are being integrated into youth-focused initiatives through Xander Sports and Apex Legacy Freedom empowering participants of all ages through structured mentorship, sports engagement, credit readiness, and financial literacy.
