I spoke with Kevin Bressendorf from Computer Spa about pricing for a POA website. (Computer Spa does the IT work for the City, so I usually see him on a daily basis).

Kevin recommends hosting the website at GoDaddy (this is where the City's websites are hosted).

To purchase a domain name the initial cost is \$11.99 a year. We should purchase the domain name for as long as allowed, because renewal prices typically increase dramatically, sometimes by 25% or more. The domain name can probably be purchased initially for at least 10 years, maybe more.

One domain name we could use is <a href="www.autumnwoodpoa.com">www.autumnwoodpoa.com</a>. This domain name is available as of right now. We can check the availability of other domain names if anyone has any suggestions.

Hosting the site at GoDaddy for the economy package is \$2.49 per month (\$29.88/year). Again, it is recommended we pay for the hosting for an extended period of time, maybe 3 years or more, because pricing typically increases dramatically when renewing.
The domain name and hosting would be in the POA's name. It would need to paid by credit/debit card (everything is done online).
Computer Spa will set up the page in Word Press with the content the Board decides at no charge.

Amendment to the covenants
Annexation agreement
List Board members and email addresses (no phone numbers)
Possibly list previous Board members (no contact information)
Minutes
Meeting notices
Financial data
We could have a picture of the sign at the entrance sign on the home page.
All Board members should have the access information to the administrative site. However, all postings should be approved by the Board. I don't know if anyone else is familiar with websites. I administer the City's website and I would be happy to post the approved documents.
If/when the website is finalized and live, we could send a notice to all property owners via postcard (less expensive than a letter). And, of course, post the link on the POA Facebook page.
