(hereinafter referred to as “Client”) and Chris Floyd acting as agent for All Focus Dog Training, LLC (hereinafter known as “Trainer”) pertains to the following:

**Training Program and Fees:** Client agrees to enroll in the Behavior Modification Program, consisting of eight (8) private one-hour sessions for a total fee of \$1,200.00, payable at the first session unless otherwise agreed upon by Trainer.

This program is designed for dogs exhibiting behavioral concerns that require specialized training and owner involvement. Each one-hour session includes:

- Approximately 30 minutes of trainer-led work with the Dog while the Client observes; and
- Approximately 30 minutes of owner-and-dog implementation with guidance and coaching from the Trainer.

Behavior modification training may address, but is not limited to:

- Leash Reactivity
- Resource Guarding
- Bite Risk Behaviors
- Stranger Danger
- Fear-Based Behaviors
- Dog-to-Dog Reactivity
- Territorial Behaviors
- Excessive Barking
- Anxiety and Overarousal
- Poor Impulse Control
- Other behavioral concerns as determined by Trainer

This program is intended to change unwanted behavioral responses and teach the Dog more appropriate reactions to environmental triggers through structured training and owner education.

**Required Scheduling Structure:** The effectiveness of this program depends on consistency and adherence to the following schedule:

- Session 1 and Session 2 must be completed within two (2) days of each other.
- Session 3 must be completed no later than one (1) week after Session 1.
- Sessions 4 through 8 must be completed once per week thereafter.

This schedule is a required component of the program. Failure to maintain the prescribed schedule may result in forfeiture of missed or delayed sessions at Trainer's sole discretion. No refunds will be provided for forfeited sessions.

**Owner Participation Requirement:** Behavior modification requires active participation by the Client. Client understands and agrees that progress depends on consistent implementation of Trainer's recommendations between sessions.

Client agrees to:

- Follow all training instructions provided by Trainer;
- Practice assigned exercises between sessions;
- Maintain consistent household rules and expectations;
- Implement recommended management and safety protocols; and
- Participate actively during training sessions.

Trainer makes no guarantee regarding the elimination of behavioral issues or future behavior, as results depend upon factors including the Dog's temperament, history, environment, genetics, and the Client's consistency in following training recommendations.

**High Risk Dogs:** Client understands that the Behavior Modification Program may include dogs exhibiting aggressive, reactive, or bite-risk behaviors.

Client agrees to disclose any known history of aggression, bites, attempted bites, resource guarding, or other dangerous behaviors before the first training session.

Trainer reserves the right to require additional safety equipment, including but not limited to leashes, long lines, harnesses, head halters, or basket muzzles, when deemed necessary for the safety of the Dog, Client, Trainer, or the public.

Trainer further reserves the right to suspend or terminate services if, in Trainer's sole judgment, the Dog presents an unreasonable safety risk that cannot be safely managed within the scope of private training services.

**Dog Health and Vaccinations:** Client warrants that Dog is physically fit, in good health, and free from contagious illness, parasites, fleas, and infectious diseases. Trainer reserves the right to refuse services if Dog appears ill or presents a health risk to others.

**Training Services:** Trainer agrees to provide private training instruction to Client and Dog with the objective of teaching Client how to effectively train, communicate with, and manage Dog.

Trainer will make every reasonable effort to assist Client in achieving training and behavior goals; however, Trainer makes no guarantees regarding Dog's future behavior, performance, reliability, or responsiveness.

Client understands and agrees that successful training requires consistent participation and follow-through. Client and all members of the household agree to:

- Follow Trainer's instructions as provided;
- Practice assigned exercises between sessions;
- Reinforce training consistently and appropriately; and
- Participate actively in the training process.

Failure to follow training recommendations may significantly affect results.

**Cancellation Policy:** Client agrees to provide at least twenty-four (24) hours' notice for any cancellation or rescheduling request.

- Cancellations made with less than 24 hours' notice will incur a \$25 cancellation fee.
- Clients arriving late may be charged a \$10 late fee.
- No-call/no-show appointments will be charged in full.
- For clients enrolled in a package program, a no-call/no-show appointment will count as one completed session.

**Release of Liability and Indemnification:** Client understands that dog training involves inherent risks and that Trainer's services may be provided in environments containing potential hazards, including but not limited to training equipment, uneven terrain, public spaces, other animals, animal owners, water, debris, and other natural or man-made conditions.

Client agrees to release, indemnify, defend, and hold harmless Trainer, All Focus Dog Training, LLC, and their agents, employees, representatives, and contractors from any claims, demands, damages, liabilities, losses, costs, or expenses, including reasonable attorney's fees, arising from or related to the services provided under this Agreement.

If Dog causes injury to any person or animal, or causes property damage during or after the term of this Agreement, Client agrees to assume full responsibility and to indemnify and hold harmless Trainer and Trainer's agents from any resulting claims, damages, losses, costs, or expenses, including attorney's fees.

If Dog is injured during training, transportation, handling, or interaction with other animals or environmental conditions, Client assumes all associated risks and agrees that Trainer shall not be liable for resulting injuries, losses, damages, or expenses except where prohibited by law.

Trainer reserves the right to terminate services immediately if:

1. Dog is determined by Trainer to be dangerous, aggressive, or unsafe; or
2. Client fails to comply with any provision of this Agreement.

Upon termination, Trainer's obligation to provide services shall cease, but all remaining provisions of this Agreement shall remain in full force and effect.

**Entire Agreement:** This Agreement is binding upon Client, Client's spouse, family members, heirs, successors, and assigns.

This Agreement represents the entire understanding between the parties and supersedes all prior discussions, representations, or agreements. No verbal promises or guarantees shall be binding unless incorporated into a written amendment signed by both parties.

Client acknowledges that Trainer has not guaranteed:

- That Dog will never bite;
- That Dog will never display aggressive behavior;
- That Dog will not develop future behavioral issues; or
- That training results will last for any specific period of time.

Any modification to this Agreement must be made in writing and signed by both Client and Trainer.

**Photo Release:** Client grants Trainer and All Focus Dog Training, LLC the right to photograph and/or record video of Client and Dog during training sessions.

Client authorizes Trainer to use such photographs and videos, with or without Client's or Dog's name, for lawful business purposes including advertising, marketing, social media, educational materials, website content, and promotional materials.
