I understand that I must have and bring my Washington Instruction Permit to every behind-the-wheel BTW lesson. To cancel, a pre-arranged BTW lesson, I must notify the instructor at least one day in advance. If I do not bring my driving permit, do not bring my required glasses/contacts, do not appear for a drive, or do not notify the instructor in a timely fashion, I will pay a \$40.00 cancellation fee before the next drive. Students needing additional drives to pass the required skills test will need to pay \$40.00 per hour for each BTW lesson.

Enrollment Eligibility

- Student must be 15 years old on the first day of class.
- Students must plan and commit to attending classes and drives.

Program

• 30 hours of classroom instruction, 5 hours behind the wheel and 1-6 hour(s) and 4 hours of Drivers Ed Interactive Risk management training.

Course Information

•Parent /student orientation is required, for parents to attend with students. This orientation is held before the start date of the course, it will go over course information, expectations, and instructions for scheduling drives. All these items are good for both parents and student information. Students are expected to participate in all 15 lessons. Any absences, (maximum 3), Student tardiness is viewed as an absence and the lesson needs to be made up.

Parent involvement is critical for the student's success!

•50 hours of supervised driving (10 of which being nighttime hours) are required by WA state prior to receiving a driver's license. If parents refuse to practice with the student and the student is unable to complete the tasks of each "Behind The Wheel" lesson, parents will need to pay for additional drives for the student to move onto the next drive lesson (\$40). This can be avoided by daily practicing at home.

Policies

•Students are fully accountable for their conduct and attendance. Students can be dismissed from the course for misbehavior (including, but not limited to, deliberate disruption of class, and deliberate disrespect of other students and L.G. DRIVING SCHOOL Staff. If faced with these, we will call the parents of the student once, as a warning, and if the behavior continues, will immediately dismiss the student from the class with no refund of tuition), cheating (whether sharing or receiving answers), being under the influence of drugs, including alcohol, during any of the instructional phases, misuse or abuse Traffic Safety Education equipment, and repeated and willful violation of traffic laws.

- If for any reason a student misses a class, the missed time will have to be made up before the student graduates the class.
- If the student missed more than 3 classes, they will be dropped from the course.
- Students under the age of eighteen complete no more than two hours of classroom instruction during any single day, except for make-up classes which shall be no more than two additional hours of class not to exceed three total make-up classes during the traffic safety education course, and no more than one hour of behind the wheel instruction during any single day.
- Class length will be a minimum of 30 days. Everything must be completed within 60 days of the start date.
