Terms & Conditions

- Adults Only. aWingIRL does not accept any clients under the age of 18.
- <u>Give Us the Truth</u>. The more thoroughly and truthfully you fill out the Questionnaire, the better we can help you. Also, we run background checks.
- <u>Be Respectful</u>. On your Encounter, be respectful, kind, fun and have a sense of humor. Hey, that's what people like.
- Your Information. In order for your Wing to become your friend, aWingIRL will collect certain personally identifiable information from you, including but not limited to your name, address, phone number, IP address, cookies, and all the other information in the Questionnaire and otherwise that you choose to share. aWingIRL may contact you with more questions, and you may provide us with more personally identifiable information at that time and at other times in the future.
- We'll Keep it Confidential. aWingIRL will only share your information with your assigned Wing
 and only those who may need to know for the sole purpose of becoming your friend enough to
 introduce you to others. aWingIRL will not share your information with any other third party,
 except that we may share aggregated anonymized data that will not be traceable back to your
 name or phone number.
- You May Not be Selected as a Friend. This could happen for several reasons or no reason at all. Background checks must be passed in order to be a Wing or a Friend. We may not have enough capacity to keep up with demand. Also keep in mind that we are looking for the right fit in a Friend who one of our Wings can confidently recommend to others.
- Payment. Payment in full is due in advance.
- <u>Background Check.</u> You agree that we will run a criminal background check on you in order to screen for felonies and/or sex offenses. No applicant with a felony or a sex offense will be knowingly allowed in to the aWingIRL network. In addition, aWingIRL will run background checks on current users on an annual basis and will remove any felons or sex offenders from the network as soon as aWingIRL becomes aware.
- <u>Encounter</u>. During your 2-hour Encounter in a public place, please dress and act appropriately, and be sociable and talkative with your Wing and prospective friends/dates. Upon arrival at your destination, you will inform your Wing which humans you'd like to meet. The Wing will then attempt, in their own way, to befriend the humans you pointed out in order to introduce you to at least 2 of the humans. Everything else is completely up to you.
- There are no refunds of any kind, ever. If your Wing fails to introduce you to 2 humans of your choice, YOU AGREE THAT YOUR SOLE REMEDY IS TO GO ON ANOTHER ENCOUNTER, EVEN IF THIS REMEDY FAILS FOR LACK OF ITS ESSENTIAL PURPOSE.
- <u>Termination</u>. aWingIRL reserves the right to terminate services for you at any time and for any or no reason.
