Seller is not responsible for any vet bills, you the Buyer may incur.

I, the undersigned Seller, assume no responsibility after said puppy leaves these premises for any changes of mind on the new owner's part, such as landlord's disapproval, allergy to animal, disagreement of family, etc. It is further understood and agreed that no warranty of representation has been made with respect to said puppy except as set forth in the agreement.
