Lastly, I understand that any resulting payment request will include a deadline for payment and that if I do not make payment by that date that BAC may allocate the mooring to someone else.

Please inform BAC promptly of any change of boat/boat name and or address/contact number, whilst still wishing to apply for a mooring to ensure continued timely communications from BAC.
