INFORMATION:

- 2. DuPont Cheese is the Official Cheese Sponsor of Manawa's Great Grilled Cheese Throw Down event and will provide all cheese used in the competition.
- 3. Every individual will produce a minimum of 30 whole grilled cheese sandwiches over the event time span and serve ¼ of a sandwich as a sample to attendees, who will vote with a ticket for the winner.
- 4. Every individual must submit their Great Grilled Cheese Recipe (name & complete ingredient list) with their entry. NO EXCEPTIONS. Recipe name and ingredients will be posted at Every individual's table. Sandwiches may contain any combination of ingredients/condiments/bread but must be constructed and grilled at the event. Precooked ingredients are fine.
- 5. Each attendee will be given one ticket to use in voting for the winner. At **1pm** the votes will be counted, the winners announced, and prizes distributed.

Rules:

- 6. Contestants <u>MUST USE</u> DuPont Cheese. An ample supply of sliced cheese varieties will be available at the event for contestants to use free of charge. (Colby, jalapeño, Colby-jack and medium cheddar).
- 7. Set up begins at **9am** and all teams must be grilling sandwiches by **11am**. Contest concludes at **1pm**.
- 8. The following equipment/supplies shall be provided by the sponsors: 1 table, electricity, paper plates, napkins, gloves, hats, advertising, insurance, prizes.
