RECREATIONAL REGISTRATION FEE

\$25.00 one-time fee due prior to commencement of first class. Payment will be removed from the automatic withdrawal account 24 hours after completing registration.

COMPETITIVE PROGRAM:

Students must audition for the program. They must also commit to each fundraiser held and any community involvement that the studio takes part in as well as any workshops held by the studio or guest choreographers. Payment for this is not provided as a discussion with Miss Kate and proper assessment must be conducted first. Prices vary from \$2,000 - \$2,500 per year PLUS competitive fees and costumes.

*All monthly payments will be PAP on the **28th** of each month. Cash is only available if the **FULL** year amount is being paid in September. **Parents are responsible for additional costs that include, proper dance shoes, tights, bodysuits & year end costumes.***

AGREEMENT:

This agreement outlines the expectations, responsibilities, and commitments required of all families with dancers participating in MK Studio's Recreational Dance Program for the 2025–2026 season.

1. Season Commitment

Enrollment in MK Studio's Recreational Program is a **full-season commitment** running from **September 2025 to June 2026**. Dancers are expected to attend all scheduled classes, rehearsals, performances, and studio functions throughout this period.

Should a family choose to withdraw for any reason (including relocation or personal choice), they agree to remain financially responsible for the **remainder of tuition and any applicable fees** for the **FULL SEASON**. The amount left owing will be removed from your account on the next monthly automatic withdrawal date. Failure to comply will result in legal action. No refunds or partial credits will be issued.

2. Tuition & Payment Policy

- Monthly tuition: **28th of each month** (Sept–June).
 - All families must provide a **void cheque or direct deposit form** before August 27th 2025, to authorize **automatic withdrawals**.
 - Missed or declined payments will incur a **\$50 NSF fee**. Payment will be removed within 5 business days along with the regular scheduled payment. Dancers may be suspended from participation until accounts are in good standing.

3. Fundraising Commitment

MK Studio organizes fundraisers throughout the season to help support competition and costume costs.

- Each family is required to sell a **minimum of 10 products per fundraiser**.
 - If the minimum is not met, a **donation of \$50 must be made to the studio** for that fundraiser.
 - This ensures fairness and shared responsibility among all families.

4. Studio Events & Representation

All recreational dancers and families agree to participate in the following:

- Community parades
- Promotional days
- Local studio events and showcases

Attendance at these events, including participation by the dancer and their family, is **mandatory** unless otherwise excused by Miss Kate in writing. These events are vital to MK Studio's public presence, team unity, and community involvement in **BOTH** Elliot Lake & Blind River.

5. Code of Conduct

MK Studio upholds a **zero-tolerance policy for bullying**, and prioritizes respect, inclusion, and kindness.

Expectations for dancers and families include:

- Positive, respectful communication with staff, dancers, and other families
- Full support of studio values and policies
- Commitment to a supportive team environment

Dancers must also adhere to the studio dress code:

- Appropriate dancewear for each class
- Hair tied neatly in a bun or ponytail
- Bodysuit and tights worn to every class
- All required dance shoes in bag each day

6. Recital & Rehearsal Policy

Recital Date & Location:

MK Studio's Annual Recital will be held in Blind River during the second week of June at:

- 117 Youngfox Road, Blind River, ON

Going forward, all studio recitals will take place at this location. Participation in the recital is mandatory for all dancers.

Rehearsals:

All dancers are required to attend scheduled dress rehearsals held during the week prior to the recital, fully prepared and in costume.

- Elliot Lake families are responsible for arranging their own transportation to and from rehearsals and the recital itself.

- Please note that Miss Kate and Miss Emilie will not be available to provide transportation. As much as we would love to help, we must focus on preparing our own children and ensuring the success of the show for all dancers.

We appreciate your understanding and cooperation.

7. Dance Attire & Shoes

After registration is complete, families will receive an email outlining the required attire for each class their child is enrolled in.

- Dance shoes (ballet, tap, jazz, acro) must be purchased directly through Miss Kate to ensure proper fit, color, and uniformity.
 - Bodysuits and tights may be purchased through Amazon or a dancewear boutique of your choice.
 - All shoes must be paid for in full prior to the season start to ensure timely arrival for the first class.

8. Costume Payment Policy

Each dancer will be responsible for the cost of recital costumes. Costume fees will be calculated and invoiced during the first week of February.

- All costume payments will be automatically withdrawn on **March 6th** using the payment method on file.
- Late payments may result in delays in ordering and receiving costumes in time for the recital plus a **\$50 NSF fee**.
