She had respiratory problems, was oxygen dependent, and suffered from post-traumatic stress disorder after watching her parents killed in Somalia's civil war. She had come here with her aunt, Sadya Dahir, seeking surgery or a heart/lung transplant. When I visited their humble home I saw a brave woman who cared deeply for her niece and a small girl who didn't let suffering rob her spirit. I helped them by making sure Fardowsa was home schooled, bringing a fan to lessen the heat that aggravated her condition, and arranging for payment of the expenses incurred in running oxygen 24/7. Fardowsa couldn't speak English, but she thanked me with smiles and touches of her hand.

MLTC Updates

On last week's Managed Long Term Care (MLTC) Implementation Advisory Group call, the state Department of Health (DOH) provided some updates on the mandatory MLTC enrollment of individuals receiving non-institutional long term care services for more than 120 days.
