SCREENING CLARIFICATION

It has been brought to our attention that there is confusion and different interpretations surrounding the temperature check portion of the kiosk screening process, specifically with the messaging from the Certify.Me app. While the Certify.Me app is designed to make the process as simple as possible, it is intended to accommodate all Trinity Health ministries. Unfortunately, it does not take into account varying state regulations. St. Joseph's Health is bound by the New York State requirement that temperatures must be taken and documented on site. Taking a temperature at home does not satisfy the requirement. Additionally, all the other screening questions must be answered and a scan of the unique daily QR code indicating that you have "passed" screening for the day must be captured.

It is mission critical that moving forward everyone is clear and follows the required / standardized behavior. Taking a temperature at home does not satisfy New York State's requirement. A temperature must be taken on site as part of the screening process. Using the app and taking a temperature at home does not permit anyone from bypassing the kiosk.

SHARPS SAFETY UPDATE: RED SHARPS CONTAINER SWAP OUT

Environmental Services (EVS) and/or Stericycle are not going into COVID-19 rooms to check/replace red sharps containers.

Unit leadership should create a plan to have COVID-19 rooms checked daily to determine if a bin needs to be exchanged. If a bin needs to be changed out, follow these steps to ensure safe pick up:

- Unlock sharps bin from wall unit (all units should have key to unlock red bins from wall mount).
- Take red cap on the new, empty bin, and place onto the disposal hole of the full bin.
- · Replace with a new bin and lock in place.
- Place used sharp bin in red biohazard bag & tie off.
- Bring bag to unit soiled utility room and call EVS X85226 for pick up.

This task can be performed by nurses in the room, or management.

INFILTRATIONS AND EXTRAVASATIONS

Recently we have seen an increase in IV infiltrations and extravasations throughout our system. Please remember to include IV assessment as part of your "5 P's Addressed" hourly rounding. Early recognition is best for patient care; stop the fluids and notify the Vascular Access Team immediately. Click here to review the policy if you have questions on how to manage these if the occur. More information and education will be coming on this soon.
