Candidates for Dixon School Board Election April 2, 2019

The Dixon Pilot is featuring the candidates seeking office in the April 2nd Dixon school board election this week. Five local residents are running

for the two seats for three-year terms on the Dixon R-1 School Board up for election Tuesday, April 2nd. Running are incumbent Doug Roam as well as David Day, Tommy Nichols, Johnny Fuller, and Stillman Buck Guisinger.

Voters will vote for two candidates on the ballot to fill the seats for a three-year term. The two candidates out of the five running receiving the most total votes throughout the school district will each be elected to a three-year term.

The candidates school board made the following comments in answer to questions submitted by the Pilot.

SCHOOL BOARD **CANDIDATES David Day - Candidate**

David Day is seeking one of the seats up for election for the School Board. Day stated that he has lived in

Dixon for 55 years, all his life, and is currently a Legislative Chief of Staff, and a former Missouri State Representative. When asked what his reasons

were for running for the school board, Day replied, "There are several reasons, but the biggest is because as a kid growing up in Dixon, our school district offered me a great education that allowed me to accomplish much more than I ever thought I could. I want to make sure that same education opportunity is available to the kids in our district today. I also feel a school should be run in large part like a private business. Have enough money in the bank for the unexpected, live within our means, take care of the people working for you, and produce a good product, in this case the education of students."

On goals he would like to see accomplished, if elected, Day said, "I feel the number one job of any school district is to make sure the young men and women graduating have the education they need to enter the workforce ro continue on to higher education. The emphasis must be on the classroom. I feel a school board's number one job is to hire the best administrators and teachers possible and give them the tools they need to accomplish that goal. A school board should spend as much time and thought in hiring a math or science teacher as they do

ing office, Nichols stated, "I was born and raised here and my entire public school life was in the Dixon R-1 School system. I thought so highly of our schools that I went to college to obtain a degree in education so that I could come back here and teach/coach here. I coached high school baseball for 13 years and taught middle school social studies and science for 22 years. My wife, Luann, also taught here in our schools for 31 years. She too retired here. Like me, she never taught anywhere else. Now three of our grandchildren are attending school here. So, ves, I have a vested interest in the betterment of our schools. Not so that they can obtain special privileges but to help all the students. I was (and still am) always very proud to tell others that I taught in Dixon because of our reputation for having such a fine educational system. I truly do love our schools and want them to be a very positive light in students' lives when they leave here. I want our schools to be the very best we can possibly make them. Our young people are our future. It is our responsibility to educate them to the very best of

our capabilities. Some goals that Nichols would like to see accomplished are, "I want our students to be successful in the world when they leave our school system. Wherever they go in life, their education will most likely determine the kinds of vocations they go into. I want to be in a position to hire the best teachers we can possibly find to make certain they get the best education there is to offer. We need to continue to get better every year. Part of the way to do that we must stay on top of STEM: Science, Technology, Engineering and Math. This is very important in today's society, regardless of what field a person enters in life. It would be

rounded education as well. That means our extra-curricular activities. I want to make sure we offer our students not only sports activities but other activities as well. I love sports. But I also love the other activities too. They should be offered. Again, though, above all, we must maintain the highest of challenging educational opportunities for our children.'

Nichols was asked what useful experience, knowledge or perspective he would bring to the office. He commented, "As a former educator in this district that spent so many years here, I have the experience as that former educator to know what our teachers need. If our teachers need something, all they should have to do is ask. As a former board member, I understand it is a big responsibility and one that I am not taking lightly. I have served on different boards for more than 25 vears. So I understand too the importance of listening to people; of talking to people. I have learned that you only make a decision after researching all the facts. Then, be honest with people. Explain yourself. That is important to being a good board member. Again, I love this school district. I was born and raised here in Dixon and came back to teach here. That is how much I thought of it and the people of the area."

Johnny Fuller - Candidate

Johnny L. Fuller is a candidate for the Dixon School Board and has lived in Dixon since 1986. He states that is current occupation is handyman.

Fuller said that the reason he is seeking a seat on the board is for improvement in the school system and special ed program.

When asked about some of his goals he would like to see accomplished, Fuller commented, "Better education and new sports and improving the administration of the schools."

The experience, knowledge, or perspective that Fuller would bring to the office is, "Listen to all parents and staff and work to build a better school, and with the experience with working with Waynesville school."

Stillman Buck Guisinger -

School Board candidate Stillman Buck Guisinger has lived in Dixon for 21 years. He is retired military and is a substitute school bus driver.

When asked why he was seeking office, Guisinger stated, "I have faithfully served by country for 23+ years and now I would like to serve my community by being actively involved in the education and future of our children who will grow up to be the leaders of tomorrow. Whether it's in our town, state, or even federal government, these young people will be involved in our country's future and I want to help ensure it is a positive experience for them and our country."

Commenting on goals to see accomplished, he continued, "Would like to see that ALL our children and schools are safe and well taken care of. I believe if you have been hired for a job you should perform that job with ALL your might! ALL the students should be represented equally and given the same fair chance in all activities. I would like to see the fine arts programs be raised to a higher level, (art, band, choir, marching band, drama, etc.). Ultimately to see that all students are properly prepared for their next step in life; college, trade school, internship, etc."

Guisinger concluded with what useful experience, knowledge, or perspective he would bring to the office. "I have been told I am very approachable and friendly. I like working with others to achieve a common goal. Over the years in the military I've had to look at the "Big Picture" and be able to work with others and start somewhere for everyone to get on the same page. I will be the voice of reason and hopefully keep us heading in the right direction and help make our schools and community Great Again."

City candidates discuss issues, answer questions at forum March 22 stood by and watched Dixon slowly deto reach out to other cities finding out what grandchildren.

By Robert C. Baker A candidate's forum for those seeking election in the City of Dixon municipal election was held on March 22, 2019 at the Dixon Elementary School. In attendance were the three candidates for Mayor: Allan Kuehl, previously an alderman, Heath Mentzer and Shawn Stevens. Only one candidate for Municipal Judge was in attendance, Brett Swanson currently a Ward 2 Alderman. The current Judge, John Ward, was not in attendance due to illness. In attendance for the Ward 1 Alderman seat was Betty Thilges, incumbent, and Anthony Campbell. For the one-year term for Ward 2 alderman were Dawna Fleming, incumbent, and Mary Wiles. For the twoyear term for Ward 2 Mike Null and Les Hansmann were in attendance. One candidate for the Ward 3 two-vear term was in attendance and that was Robert Leonard a write in candidate, Diane Shultz, the incumbent was absent.. Serving as moderators were La'Shun-

dra Conner and Orlando Ochoa from A Mustard Seed CDC. Ms. Conner welcomed the candidates and the public in attendance then explained why everyone was there and how the forum was to be conducted. She explained that the candidates should think of the forum as a job interview, not a debate, and think of how to best improve Dixon. This can cover policy, growth and development and infrastructure to name a few. Ms. Conner thanked those in attendance for their desire to be better informed for the upcoming election. She explained that if those in the audience had a question for a candidate, or all the candidates, they should fill out a card at the moderator's desk. The moderators would then sort the cards and ask the question to the candidates giving the candidates two minutes to answer. For those questions asked of one candidate, after that candidate answered the question, it would then be opened up to other candidates.

The candidates, starting with those for Mayor, were given a two minute time period to introduce themselves, state what position they were running for and tell the audience why they felt they were the best qualified candidate for the office. This introduction included their name and some

background information on themselves. The first candidate to address the audience was Allan Kuehl running for Mayor. As background he stated that he was raised in Iowa and came to Fort Leonard Wood while in the Army. He bought a house in Dixon in 1986 and recently turned 65. Mr. Kuehl stated that he had been on the city council in 1997 and other times after that. Important to Mr. Kuehl, as mayor, would be to know where the money is as far as income and expenses. He stated that he has tried to keep abreast of the proceedings of the city council, what people might want and expect. Mr. Kuehl thinks that it is possible for the city to bounce back from its current situation.

Heath Mentzer was the next candidate for Mayor to address the audience. He was raised in Iowa also and while in the Army moved his family to Dixon in 2011. Mr. Mentzer retired two years ago from the Army as a Criminal Investigation agent. He stated that he is thankful to have a chance to be a part of this democracy. Being active in scouting Mr. Mentzer said them and helping them make a better future for all. Mr. Mentzer stated the attributes he brings to the office of mayor are leadership, order, organization and discipline. He said it is important to be a team, that no one knows all the answers but by knowing where to look and working to-

gether the city can accomplish anything. Shawn Stevens was the last candidate for Mayor to address the audience. He is a retired Army Warrant Officer that has lived in Dixon since 2006. As an engineer Warrant Officer at Fort Leonard Wood, Mr. Stevens taught both the basic and advanced courses. His experience includes and has been there for 17 years working in power systems, water and wastewater systems, and waste treatment plants. Mr. Stevens also has been a facility engineer at a combat hospital and brings both engineer and project management experience. He also has experience building teams to complete projects and stated the key is to know where to find answers since no one knows everything.
